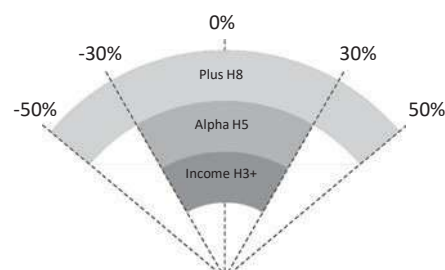

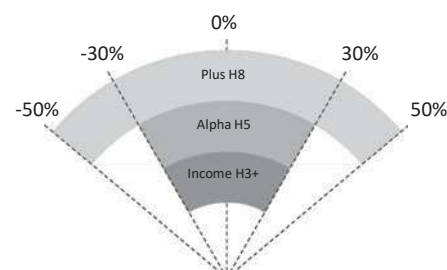


Asset Allocation
