Description of this Fund

The Fund is a New Zealand-domiciled diversified portfolio that invests primarily in Defensive assets, such as Fixed Interest and Cash. The portfolio has allocations to Equities, Fixed Interest, Real Assets, and Cash. The portfolio employs an active approach to asset allocation and a predominantly active multi-manager approach to security selection.



Example of how this applies to an investor


Jane had \$10,000 in the Fund at the start of the year and did not make any further contributions. 
Actual investment mix
