What is the purpose of this update?

Description of this Fund

The Fund is an Australian-domiciled diversified portfolio that invests in Defensive assets, such as Fixed Interest and Cash, and Growth assets, such as Equities. The portfolio has allocations to Equities, Fixed Interest, Real Assets, Cash and Alternatives. The portfolio employs an active approach to asset allocation and a predominantly active multi-manager approach to security selection. The Fund currency is Australian Dollars (AUD).

What are the risks of investing?

Example of how this applies to an investor³

Jane had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Jane received a return after fund charges were deducted of \$803 (that is 8.03% of her initial \$10,000). Jane paid \$0 in other charges. This gives Jane a total return after tax of \$670 for the year.


Actual investment mix
