## What are Assistive Listening Systems?

Just like wheelchair ramps help people with mobility issues, assistive listening systems (ALS) help people with hearing issues. The Americans with Disabilities Act (ADA) requires all government and public venues to provide hearing-aid compatible ALS where there is amplified sound. The ADA also requires venues to provide ALS system receivers if needed.

You can find ALS in theaters, places of worship, retail and information counters, transportation hubs, etc. These systems send audio from the sound source directly to your hearing devices. ALS reduce the impact of distance and poor acoustics and can minimize background noise. The types of ADA-compliant Assistive Listening Systems include hearing loop, FM and Infrared (IR) systems. To take full advantage of these systems, users must have a telecoil in their hearing aids or cochlear implants.
