(ii) EVALUATION AND AWARD OF THE CONTRACT:

• The financial proposal does not exceed the maximum available budget for the contract

The award will be made to the applicant who obtains the highest technical score. Expressions of Interest not obtaining a minimum score of 70% will be rejected.

1. Background

Common Market for Eastern and Southern Africa (COMESA) Federation of National Association of Women in Business (COMFWB) is one of COMESA institution supporting the development and participation of women owned SMEs in regional integration.

The COMESA Treaty under Article 154 and 155 acknowledges critical role that women play in their social economic spheres in line with the COMESA gender policy. COMESA has set up two institutions and agencies supporting private sector development. The COMESA Federation of National Association of Women in Business (COMFWB) is one of the COMESA institutions with a mandate of supporting women led private sector organizations.

COMFWB has been implementing its medium-term strategic plan which focus on supporting provision of business development services to entrepreneurs and creating Jobs for women and youths through creation and strengthening of existing Business incubation centers.

COMFWB has partnered with CO-WATER international in the implementation of the Facilitating Inclusive Resilient and Sustainable Trade (FIRST) Project funded by Global Affairs Canada (GAC). The project supports the implementation of the African Continental Free Trade Area (AfCFTA) and regional trade agreements through gender-responsive, inclusive, and environmentally sustainable (GRIES) approaches.

In the FIRST project, Activity 1223.2.1 contributes to Intermediate Outcome 1200, which aims to strengthen the capacity of Micro, Small, and Medium Enterprises (MSMEs)—particularly small-scale cross-border traders (SSCBTs), women, youth, and persons with disabilities—to access and benefit from national, regional, and continental trade opportunities.

COMFWB would like to engage a service provider to develop training materials which will be used for the training of women entrepreneurs in Zambia and Democratic Republic of Congo.

2. Specific Objective

The specific objective of this call is to develop accessible, gender-responsive, and context-specific training manuals and practical tools to strengthen the capacity of MSMEs, with a particular focus on women, youth, and persons with disabilities (PWDs). These resources will enable MSMEs to expand their businesses, enhance market access, and effectively leverage opportunities created under the AfCFTA and other regional trade frameworks.

3. Scope of the Assignment

The training manuals and tools will specifically cover:

- **Business Development:** Core skills for enterprise growth, market positioning, and sustainable operations.
- Financial Literacy and Financial Management: Strengthening MSMEs' ability to manage finance effectively, improving financial decision-making, and enhancing access to finance.
- **Social Commerce:** Practical guidance to help MSMEs, particularly women, youth, and PWD traders, leverage digital platforms and social media to expand market reach, increase sales, and transition towards more formal participation in trade.

4. Expected Results and Deliverables

The consultant, once contracted, is expected to provide COMFWB with the following deliverables:

- Business Development Modules: Develop practical, accessible training
 materials covering business planning, pricing strategies, market access,
 supply chain linkages, marketing, and customer relationship management,
 tailored to the realities of small-scale cross-border traders (SSCBTs),
 particularly women, youth, and PWDs.
- Financial Literacy and Management Modules: Develop targeted materials on financial planning, budgeting, recordkeeping, credit preparedness, risk management, and engagement with financial service providers, specifically adapted for SSCBTs operating in informal and low-literacy environments.
- Social Commerce Modules: Produce user-friendly training content to equip SSCBTs with the skills to leverage social media, mobile platforms, and digital tools for marketing, sales, customer engagement, and cross-border transactions.

5. Assignment Duration,

The anticipated period for this scope of work is 1 month.

6. MINIMUM REQUIREMENT

The candidate should

- a. Have minimum of (5) years of consultancy Experience in market access, market research, innovative products
- b. Be able to inspire and conduct capacity building of women entrepreneurs for market resiliency.

- c. Be able to create and deliver training manuals (general and specific sector) for any entrepreneurs.
- d. Have a background working with African Women and youth Entrepreneurs in small scale cross border trade.
