How do we get a 2 sec message to the officials?

Are the officials concerneed about their vote with the voters?

Oregon - Nike is based in Oregon. They employ a ton of Nike. So no one attacked Nike. Comcast the cable company everyone was behind with focusing on bc everyone hates the cable company.

If that does come in don't highlight in primary story...most employees don't have a say in company's politics. Most of the time the company's politics hurt the employees.
