## **Funding for projects which support Adults**

## **The Visa Foundation – CatalyseHer Programme**

#### **Summary**

The programme is designed to support women-led businesses with a focus on social and environmental impact in the UK. The three-year initiative will provide 500 women entrepreneurs with micro-grants, alongside two months of training and community-building support to help them grow their businesses and become investment-ready.

There are two learning tracks for this cohort:

- The Fundamentals Track for early-stage businesses with an annual income under £50,000 who are looking to refine and strengthen their business model
- The Impact Track for those ready to scale their social impact.

#### **Key Criteria**

- To be eligible, businesses must be less than five years old with an annual income below £2 million.
- Applicants must be Women founders, co-founders, or CEOs of businesses based in the UK (registered on Company House or HMRC registered)

Amounts available: Maximum £5,000

**Application deadlines**: 7<sup>th</sup> September 2025 (Training starts 17<sup>th</sup> September 2025).

#### Alzheimer's Research UK's - Inspire Fund

#### **Summary**

Funding is available for a range of organisations and individuals, to engage diverse and underserved audiences, including ethnic minority, marginalised, and socioeconomically disadvantaged communities with innovative public engagement projects that raise awareness of brain health and dementia risk reduction.

#### **Key Criteria**

- The scheme prioritises applications from underrepresented parts of the UK—particularly Scotland, Wales, Northern Ireland, and regions of England such as the Midlands, North West, North East, Yorkshire, and East Anglia
- Particularly encourage collaborative applications, and those that build relationships between communities and researchers.
- Projects must be UK-based and last up to 12 months
- Eligible costs may include staff time, materials, accessibility, and evaluation.

Amounts available: Maximum £5,000

Application deadlines: 8th September 2025

## **Help the Homeless**

### **Summary**

Capital funding is available for small homelessness charities to support homeless people rebuild their lives. Typically, organisations awarded funding operate residential or training facilities to assist homeless people.

#### **Key Criteria**

- Charities must have an annual turnover of less than £500,000 and unrestricted reserves of less than six months.
- There should be a minimum period of two years between the receipt of a decision or grant awarded and making a further application.

Amounts available: Maximum £5,000

Application deadlines: 15<sup>th</sup> September 2025

## **Armed Forces Covenant – Family Focus Programme \* (NEW GRANT)**

#### **Summary**

Funding is available for projects that explore and pilot solutions for family members-collectively and as individuals of wounded, injured and sick serving personnel or Veterans.

The focus for 2025/26 is supporting projects that test new ideas, refine successful pilots, or expand services developed in the past five years, provided they are not part of an organisations core work.

Projects will need to meet one or more of the following outcomes:

- Family members of those who are wounded, injured or sick feel better informed and more able to access relevant information, advice and guidance, applicable to their situation
- Family members of those who are wounded, injured or sick feel less lonely/isolated, more resilient and better equipped to deal with their circumstances
- Family members of those who are wounded, injured and sick have developed their skills for work, or have greater confidence to pursue volunteering or employment when it's right for them

## **Key Criteria**

- Applications are welcome from Registered Charities, Community Interest Companies (CICs),
   Local Authorities and NHS organisations
- Projects should be for between twelve and eighteen months

Amounts available: Between £50,000 and £100,000

Application deadlines: 24th September 2025

#### **Armed Forces Covenant – Hidden Voices \***

#### Summary

Funding is available for local authorities, registered charities and Community Interest Companies (CICs) with significant recent experience supporting Armed Forces communities to support the mental health and well-being needs of marginalised groups within Armed Forces communities.

The programme aims to identify and fill gaps in service provision and foster collaborative partnerships between Armed Forces organisations and specialist non-armed Forces organisations

#### **Key Criteria**

Projects should last up to 12 months

Projects will need to meet both of the following outcomes:

- Those who are underrepresented, or whose voices are seldom heard, within the armed forces
  community, have equitable access to mental health and wellbeing support which meets their
  specific needs.
- Awareness of the needs of underrepresented groups within the armed forces community has been raised among organisations supporting them, through mutual learning and knowledge exchange to embed best practice.

Amounts available: Between £3,000 and £25,000

#### Application deadlines:

- 1st October 2025 (Decision by end of November 2025)
- 21st January 2026 (Decision by end of March 2026)

## **Concertina Charitable Trust**

#### Summary

Funding is available for charitable organisations and care homes for the elderly to run activities which provide musical entertainment and related activities for the elderly

#### **Key Criteria**

- Applications will automatically be refused if they do not include a copy of their accounts or financial statements with the application
- The Trust is particularly keen to act as a catalyst via matched funding.

Amounts available: Maximum £250

Application deadlines: 31st October 2025

## **Charles Hayward Foundation – Small Grants (NEW GRANT)**

#### **Summary**

Funding is available for charities to support preventative and early community-based services or programmes that focus on helping older people stay in their own homes and maintain their independence.

There are three categories:

- Programmes aiming to alleviate isolation and depression in older people, including informal day care, or regular social, physical and recreational activities.
- Programmes which give practical help, assistance and support for older people living in their own homes.
- Programmes addressing the emotional and practical needs of people with dementia and their carers.

#### **Key Criteria**

- Charities should have an annual income of under £350,000
- Projects should exclusively benefit people over the age of 60

Amounts available: Maximum £7,000

**Application deadlines**: Open – applications are accepted anytime

## Funding for projects which support Children and Young People

#### SIB - Better Youth Spaces Programme \*

#### Summary

Funding is available for youth organisations in specific geographic locations to undertake small-scale capital projects, including purchasing equipment and refurbishment projects. The fund will support youth organisations working with disadvantaged young people aged 11 to 18, or up to 25 for those with additional needs or vulnerabilities.

Projects must meet at least one of the fund objectives:

- Improving the reach of activities provided
- Improving the safety of existing youth facilities
- Improve the youth sector's capacity and quality to deliver a range of enrichment activities
- Funding priority areas on the basis of youth need
- Improving the financial sustainability of youth facilities

#### **Key Criteria**

- Leicester is one of the 42 priority areas
- Please note: the eligible postcode area relates to the building/land being refurbished or where the equipment being purchased will be stored.
- Although the minimum grant size is £5,000, for equipment to be classed as capital and therefore eligible, all equipment items that make up the grant of £5,000 or more must each be £2,000 or greater in value.
- The fund cannot consider part funding or match funding requests due to the timescales for this funding to be spent. Applications must cover the full costs of the work/ equipment.
- Local authorities can apply where they provide youth services

Amounts available: Between £5,000 and £100,000

#### Application deadlines:

- Applications for refurbishment have been extended to 21st September 2025
- Applications for equipment will remain open until 21st September 2025, unless oversubscribed

#### The National Lottery Community Fund - #iwill Fund 2025 \* (NEW GRANT)

#### **Summary**

Funding is available for voluntary and community organisations, along with statutory bodies to support youth led social action. That is young people playing an active role in addressing the issues of a specific place or area that matter most to local people.

Eligible projects can include environmental action, peer mentoring, health campaigns, tackling food insecurity, intergenerational initiatives, support for carers and disabled young people, and creating new youth networks.

Organisations must show how the project:

- Creates place-based youth social action opportunities for young people
- Will help young people get involved in social action. This should be throughout their life, even after the funding ends
- Will reach young people who have not taken part in regular social action activities
- Will continue, even after the funding ends
- Involves the voices of young people. They should also be a part of your organisation

## **Key Criteria**

- Projects must be aimed at those up to age 20, or 25 for young people with additional needs
- Applicants must match at least £200,000 in cash or in-kind contributions
- Projects must be completed by March 2027

**Amounts available**: Minimum grant £200,000 (Only expect to fund 4-6 projects). Total available budget £3 million.

**Application deadlines**: 24<sup>th</sup> September 2025 for Expressions of Interest

## Active Together -Young People Physical Activity & Sport Hardship Fund (NEW GRANT)

#### **Summary**

The Fund is specifically for and aimed at helping individual young people overcome financial constraints affecting their involvement in physical activity and sport. There are four categories:

- Participant for young people who are not able to access ongoing sport or physical activity due
  to the cost of membership fees/subs or who may need support with the purchase of kit or
  equipment required to participate.
- Coach/Official for young people who have a passion for coaching or officiating in sport but are unable to access coaching or officiating courses/qualifications due to the cost of training.
- Volunteer for committed young people who would like to give their time to volunteer in sport
  or physical activity, however they may face barriers such as the cost of transport to access the
  activity.
- Talented sportsperson for young people who compete at a Regional, National or International level however cost is a barrier to travelling to competitions, purchasing equipment

#### **Key Criteria**

- Young people must live in Leicestershire, Leicester or Rutland
- Young people must be aged between 7 21 years old, or up to the age of 25 for young people with special educational needs and disability (SEND)
- For young people under the age of 18, applications must be completed by a parent or guardian on their behalf.

**Amounts available**: No minimum or maximum amount, however previous grants have been around £200 to £300.

**Application deadlines**: 5<sup>th</sup> October 2025 and 1<sup>st</sup> March 2026

## **Armed Forces Covenant – Early Years Programme \* (NEW GRANT)**

#### **Summary**

Funding is available to support early years education for children from Armed Forces families.

Applications are invited from:

- Early childhood education and childcare providers operating where armed forces families live or work and must offer group-based childcare and have at least 50% of service children on roll (unless under a cluster, see below).
- Local authorities who wish to supply specific training to early childhood education and childcare
  providers supporting service children aged 0-5 years and provide a shared resource working
  across multiple settings.
- Setting that have less than 50% service children on roll, could still apply as a cluster. This
  means submitting a group bid on behalf of two or more settings with smaller numbers of
  service children.

Projects will need to contribute towards at least one of these outcomes:

- Increase capacity at the setting to allow more service children to attend
- Provide better learning environments for service children
- Provide appropriate training and development of staff to support service children
- Establish collaborative networks and shared resources through clusters to address the needs of service children

#### **Key Criteria**

- Applicants must be a registered charity, a CIC, or a company limited by guarantee or a local authority in one of the four countries of the UK.
- Charities must have been registered in the UK for at least three years at the time of your application and able to provide published accounts for all three years if requested.
- CIC's must have been incorporated in the UK for at least three years and you must have submitted three years of accounts to Companies House at the time of applying
- Organisations cannot apply more than once per funding round to this programme unless this is for programmes of work in different places (e.g. charities that run nurseries in two eligible locations)

Amounts available: Between £5,000 and £80,000

Application deadlines: 8th October 2025

## **Universal Music UK Sound Foundation – School Award (NEW GRANT)**

#### **Summary**

Funding is available for schools across the UK and Ireland that teach the national curriculum, to improve their access to music by purchasing or upgrading musical instruments and/or equipment.

#### **Key Criteria**

- Successful applicants will have approximately 2 months to claim the donation
- The Foundation is unable to accept applications on behalf of Trusts/Academies for multiple schools, each school must submit their own application form
- Unable to fund retrospectively and you are not eligible for financial assistance if you have already purchased your resources or if you buy them after you submit your application, but before an offer of funding is made
- If you have applied for funding in the past and were successful, please wait for two years from when the funding was offered before applying again

Amounts available: Maximum £1,000

Application deadlines: 21st October 2025

## National Lottery Community Fund - Million Hours Fund \*

#### Summary

Funding is available for a range of organisations (including local authorities) to give extra support to young people in areas with higher rates of anti-social behaviour. It will fund extra hours of youth work to give these young people more places to go and positive things to do.

#### **Key Criteria**

The work must take place in, or benefit young people living in, one of the <u>eligible ward areas</u>. Leicester and Leicestershire both have eligible wards.

To apply, your project must:

- Benefit young people aged 10 to 18, or up to 25 if they have special educational needs or disabilities (SEND)
- Effectively engage with young people at risk of taking part in anti-social behaviour
- Deliver more hours of youth work than you provide now
- Involve young people in deciding how you work
- Deliver youth work that is open to as wide a range of young people as possible (known as 'open access')
- Be run by trusted adults such as qualified youth workers, youth support workers, or experienced volunteers

Amounts available: Between £30,000 and £100,000

**Application deadlines**: 22<sup>nd</sup> October 2025 (The application window may close early if the scheme becomes oversubscribed).

## **Duke of Edinburgh - Access Funding (NEW GRANT)**

#### **Summary**

State-funded specialist schools, Alternative Provision settings, and Pupil Referral Units (PRUs) in England can apply for grants to enable young people with disabilities and additional needs to take part in the Duke of Edinburgh's Award (DofE) scheme.

Funding can be used to purchase equipment for the Volunteering, Physical, Skills, and Expedition sections as well as 75% of the 2025/26 annual DofE license fee and provides fully funded Bronze, Silver and Gold participation places to remove cost barriers for young people with disabilities and additional needs.

## **Key Criteria**

- The organisation is a state funded Special Educational Needs and Disabilities (SEND) school, Alternative Provision (AP), or Pupil Referral Unit (PRU) that receives funding through their local authority or directly from the government
- The organisation does not currently have a DofE license
- The organisation has not terminated a DofE license in the past six months at the point of application

Amounts available: Maximum £4,500

**Application deadlines**: 11<sup>th</sup> December 2025

## **The Outward Bound Trust – Adventure Fund (NEW GRANT)**

#### Summary

Funding is available in the form of bursaries for schools or youth groups to help young people (aged between 11 and 24 years) from across the UK access outdoor education programmes run by The Outward Bound Trust.

#### **Key Criteria**

Applications are open to both individuals and organisations, with priority given to those facing financial hardship or disadvantage

**Amounts available**: Bursaries cover up to 40% of course fees

**Application deadlines**: No application deadlines are provided, but it states: "Early applications are encouraged, as funding is limited and awarded on a first-come, first-served basis".

## Paul Hamlyn Foundation - Youth Fund (NEW GRANT)

#### **Summary**

Funding is available for not-for-profit youth organisations which support disadvantaged young people aged 14 to 25. Funding is for core operating costs and to help grow the impact of what organisations already do.

#### There is a focus on:

- Targeted work with and for young people who face transitions in their lives which may be challenging or create barriers for example into or out of education, care settings, housing or the secure estate (including prisons, bail accommodation and youth detention accommodation).
- Work that recognizes young people's multiple and overlapping identities (for example race, gender, sexual orientation, class, faith, migration status, ability).

### **Key Criteria**

- The Foundation will prioritise work that takes place outside of London.
- Organisations should have an annual turnover of over £30,000 and under £3.5 million
- At least 50% of the organisation's focus is on work with and for 14–25-year-olds
- For work delivered through partnerships, there must be a lead partner who can receive funds and the partnership must already be active
- The Fund is not looking to support new or untested approaches, projects or finite pieces of work

Amounts available: Maximum £150,000 over three years

**Application deadlines**: Open – applications can be submitted at anytime

## Funding for projects which support broader community outcomes

## Leicestershire County Council – Get Ready Community Energy Fund

### **Summary**

Community organisations can apply for funding to kickstart renewable energy and energy efficiency projects in their area.

Projects may include those that reduce the energy use of homes or community buildings and renewable energy generation projects such as photovoltaic panels, heat pumps and wind turbines.

Eligible costs may include:

- Undertaking feasibility studies
- Costs of structural surveys, planning applications, contracts and legal fees
- Developing demonstration projects that help educate people about community energy

The funding is intended for project development costs and cannot be used to directly fund the cost of installing renewable energy unless the installation is part of a demonstration project for the wider community

Successful applicants will be allocated a project mentor to help make the project a success and will be invited to join the Community Energy Leicestershire Forum

#### **Key Criteria**

- Applicants must be part of a community group or other organisation with a dedicated bank account and has plans in place to develop energy efficiency and or renewable energy projects that benefit local people
- The fund is not open to individuals or limited companies
- The main beneficiaries must be residents of Leicestershire, excluding Leicester City and Rutland
- The grant must be spent by 28<sup>th</sup> November 2025

Amounts available: Not disclosed, but the total budget available is £140,000

**Application deadlines**: Open, but the scheme will close to new Expressions of Interest on 8<sup>th</sup> September 2025

#### **Henry Smith Foundation – Domestic Abuse Fund (NEW GRANT)**

#### **Summary**

Funding is available for registered not-for-profit organisations offering specialist, person-centred services for people experiencing domestic abuse, particularly within marginalised and minoritised communities.

#### **Key Criteria**

- Eligible applicants must have at least three years' experience, deliver consistent one-to-one
  casework, and provide wrap-around services such as counselling, safe accommodation,
  immigration advice, and culturally specific support.
- Organisations must be "led by and for" people who are from marginalised and minoritised communities that face additional forms of discrimination, and structural and systemic inequality.
- No organisational maximum or minimum income eligibility requirements

**Amounts available**: Maximum £250,000 (£50,000 per year for five years). Expect to make twenty grant awards.

**Application deadlines**: 10<sup>th</sup> September 2025 for Expressions of Interest

## **HM Govt. – Digital Inclusion Innovation Fund** \* (NEW GRANT)

#### **Summary**

The UK Government has launched a £9.5 million fund to tackle digital exclusion and expand online access as part of its Digital Inclusion Action Plan priorities:

- Improving digital skills
- Improving access to digital services
- Improving data and device poverty
- Improve confidence in the use of digital services

Initiatives should target vulnerable groups such as older people, job seekers and low-income households, the fund will support projects ranging from digital skills training and improved device and connectivity access to confidence-building programmes, innovative pilots, and scaling proven best practices.

The fund will also cover the purchase of capital assets like devices and assistive technologies.

## **Key Criteria**

- Projects must be completed by 31<sup>st</sup> March 2026
- Charities must have been registered for at least one year from the date that this Fund went live
- A consortium must have a Lead Organisation to serve as the main contact point through which the grant can be awarded and managed

Amounts available: Between £25,000 and £500,000

Application deadlines: 10th September 2025.

#### The Society Foundation

#### **Summary**

Funding is available for UK-registered charities and charitable organisations seeking to help people move towards paid employment who are either ex-offenders, the recently homeless or vulnerably housed, or 16-24 year-olds not in employment, education or training.

#### **Key Criteria**

Organisations should:

- Have a turnover of up to £500,000
- Be working in capacity-building activities, including IT infrastructure and equipment, staff training and development, and external consultancy/support

Amounts available: Maximum £2,500

**Application deadlines**: 12<sup>th</sup> September 2025

## **UKRI - Gambling Harms Funding \***

#### Summary

UK Research and Innovation (UKRI), supported by the statutory gambling levy, is launching two linked grants to advance the new Research Programme on Gambling:

Gambling Harms Research and Innovation Partnerships (GHRIPs) Grant - funding partnership development and evidence analysis through interdisciplinary consortia involving academia, business, government, and third-sector partners. Successful applicants may later apply for larger phase two awards.

Gambling Harms Research Coordination Centre (GHRCC) Grant - to coordinate and manage the programme, supporting research scoping, partnership building, and capacity development.

#### **Key Criteria**

For GHRIPs Grant:

- Project co-leads from government, local government, third sector and non-profit organisations and industry are eligible and encouraged for this funding opportunity.
- The full economic cost of your phase one project can be up to £100,000

#### For GHRCC Grant:

## **Electrical Safety First - Electrical Safety Fund (NEW GRANT)**

## **Arnold Clark – Community Fund (NEW GRANT)**

#### **Summary**

Funding is available for organisations working in one of three themed areas:

- Community Support for youth groups and clubs, animal welfare, arts and culture, community enhancement, education training / advancement, mental health, relief support, sustainability enhancement and projects.
- Gear Up for Sport for youth groups and clubs

#### **Key Criteria**

- Organisations must be operating within 50 miles of an Arnold Clark branch. Note that there are branches in Nottingham and Burton on Trent so a good proportion of Leicestershire and Leicester will be eligible
- Community Support and Gear Up for Sport themes organisations can apply once per year
- Cost of Living theme organisations can apply every six months

Amounts available: Maximum £2,500

#### Application deadlines:

Open. Applications are accepted on a rolling basis but it is recommended to apply as early as you can once the fund is open, as applications could be paused due to high demand.

The three themed areas have separate application windows throughout the year.

For example: Cost of Living is open in September

#### **Co-operative Bank – Customer Donation Fund (NEW GRANT)**

#### **Summary**

Organisations with a Community Directplus account at the Co-operative Bank, such as registered charities, co-operatives, and credit unions, can apply for funding for a wide range of projects and activities that enhance the community and the environment.

#### **Key Criteria**

The fund won't support trips or holidays, salaries, rent and running costs

Amounts available: Maximum £1,000

**Application deadlines**: Open (applications can be submitted ant anytime).

## **Nineveh Charitable Trust (NEW GRANT)**

#### **Summary**

Funding is available for UK based schools and not for profit organisations undertaking a broad range of projects and activities that promote a better understanding of the environment and countryside, whilst facilitating improved access, education and research.

## **Key Criteria**

NB Applications are via post only.

Applications must support the Trusts objectives:

- The health, welfare and education of the general public
- The study and appreciation of agriculture, silviculture, ecology and land management
- The study and appreciation of land and estate management that encourages conservation of the countryside

**Amounts available**: Suggested maximum £5,000 (per year for up to three years)

**Application deadlines**: Open (applications can be submitted ant anytime).

## **Moto Foundation – Community Grants (NEW GRANT)**

#### **Summary**

Funding is available for charities, schools, and community organisations to support various projects that directly benefit the communities where Moto operates or has a significant staff presence.

## **Key Criteria**

- Organisations must be operating within a 15-mile radius of a Moto Motorway Services site
- Applications should have the endorsement of a Moto colleague; that is, someone directly employed by Moto Hospitality Ltd
- The application to approval process can take up to 8 weeks to complete

Amounts available: Maximum £1,000

**Application deadlines**: Open (applications can be submitted ant anytime).
