



Information and Application

Thank you for your interest in honoring an Allen County-Scottsville military veteran.

This program is intended to provide the opportunity to salute our brave men and women who have served our community and country by obtaining customized banners to be displayed on lamp posts around downtown Scottsville. Banners will be double-sided with a different veteran on each side. Active-duty service members are not currently eligible for this program due to the limited number of display locations.

Please read the information below and complete the application form to obtain a banner for the veteran you'd like to honor. At this time only one application may be submitted per person.

Important Notes

- Applications will not be accepted until ALL information is complete with a photograph and verification of military status, such as DD214 (certificate of release or discharge from active duty), SF180 (request for military service records), etc.
- All submissions will be vetted to confirm proof of service before banners are created.
- Banners will be proudly displayed downtown Scottsville as a symbol of our community's gratitude.
- Banners are the property of the Allen County Fiscal Court and the City of Scottsville.
- The individual to be honored and recognized must reside or have resided in Allen County or the City of Scottsville. Ways to verify residency census records, driver's licenses, yearbooks, tax records, birth, marriage, death certificates, newspaper clippings, etc.
- Banners will be placed without reserved locations.
- No additional embellishment or decoration of the banners or lamp posts upon which they are mounted is permitted.
- Only one banner may be displayed for any individual service member.
- Banners will be rotated throughout the year to feature different veterans.

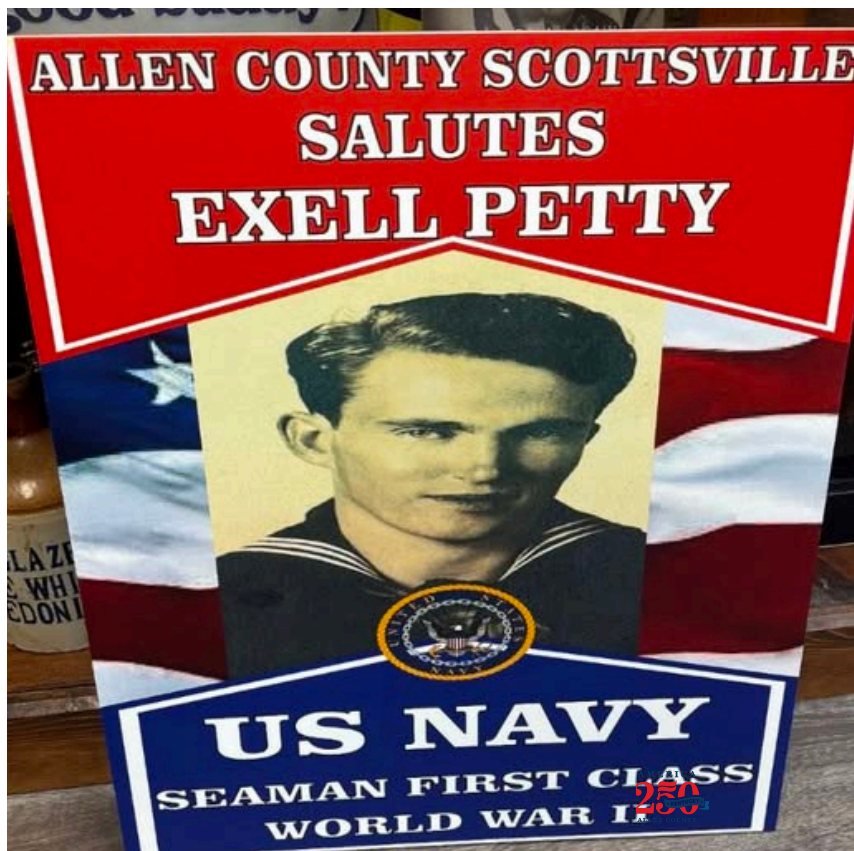
