The motion passed with thanks to the TED committee for their wonderful work.

Debbie then presented the following motion:

To call a congregational meeting on June 1 at 9:30am to elect the officers for the class of 2028 and one member at large for the TED committee.

The <u>motion was made and seconded</u>. Following a brief discussion regarding the timing of the meeting, the motion passed.

Per our bylaws, the meeting will be advertised 2 weeks prior to the meeting. The meeting will also include a current year budget update.

#### **Trustees Update: Kathy Haddock**

- The trustees have a meeting scheduled with the Learning Care Group who manages the preschool to discuss their underperformance.
- The construction schedule for the 1603 Walnut project is on track overall. Xcel has impacted the project by the delay in relocating the overhead power lines.
- The Boulder Police Department will be providing a security training for the staff and any church officers who wish to attend.

#### Ministry Year 2026 Budget 1st reading: Larry Drees

In addition to the materials included in the Session Packet, Larry distributed an overview of covenant partner giving and a new summary of suggested budget modifications for MY26.

The MY26 budget under review is \$3.6mil. Trustees are recommending that Session do not approve a deficit budget. Larry recommended that the budget be \$3mil.

A lengthy discussion followed including how to increase giving among the current contributors, how to attract new giving units, and how to align the budget with the church's ministry needs and donations.

Anthony shared that our budget distribution closely aligns with ECO's recommendations: 60% personnel costs

4-5% missions10% program costs20% business/administration/facilities5% contingency

Greg Parr, Doug Rutherford and any other elders who are available, will meet with Larry on Tues, May 13, 9:30am to review the options to match the MY26 budget to projected giving.

#### **Personnel Organizational chart: Anthony**

Anthony reviewed the proposed staff organizational chart that was included in the Session Packet.

The organizational chart allows for

- no staff layoffs by reallocating staff to other open or new roles
- a new position of Director of Engagement as a role for Jenn Ceder
- some future positions to remain unfilled in this next year

Dave Pommer is attending his last ECO ordination retreat with the hope that he is will be ready for ordination this summer.

Related to the personnel work, Debbie Carosella presented the following motion:

To approve the Search Committee as listed for the Director of Finance and Operations position.
