Timpanogos Legal Center (TLC) continued to successfully deliver direct legal services in the areas of family, housing, and abuse law for victims of abuse and low-income Utahns. In 2024, TLC continued to expand services to rural Utah, including the strengthening of legal advice clinics in Sanpete, Millard, and Duchesne counties. The organization evaluated the Document Preparation Clinic and identified and implemented several improvements to the intake and case assignment procedures that have improved the experience of TLC clients and have delivered services more effectively. TLC programs served 8,952 clients in 2024. TLC expanded their team from 13 to 15 team members to respond to ever-increasing requests for service.
