The hotline continues to be one of our most in-demand programs. Clients can text, email, or call our team to receive brief advice and referrals. We responded to 4,108 hotline contacts in 2022, an increase of 10.6% from the previous year.

Certified Advocate Partners Program:

In 2020, the Utah Supreme Court authorized a legal regulatory sandbox, a framework for legal service providers to deliver services in new and innovative ways. Our application for the Certified Advocate Partners Program (CAPP) was approved in February 2021, and we began offering services via this program later that year. In 2022 we trained an additional 7 advocates, bringing the total of Certified Advocates to 12 throughout the state.

The primary purpose of the Organization is to provide free legal services to low-income people and victims of domestic violence. Our mission is to empower victims of domestic violence and low-income Utahns to navigate the legal system through innovative and trauma-informed legal services.

The Organization recruits and trains legal professionals to provide pro bono work in new and meaningful ways, which enables thousands of people each year to pursue or defend their rights in court and ensure stability and security for their families. We named our organization after Mount Timpanogos with the vision that we will lift our clients like the peaks of the mountain elevate our eyes upward. Our motto is "Lifting Lives through the Law".

We experienced growth across our programs and provided 6,561 services to clients, a growth of 19.8% from 2021.

Document Clinic Cases:

Our staff and volunteer attorneys draft certain pleadings for parties who are representing themselves in their family law cases. We served 219 clients, an increase of 32% from 2021. We assisted with 896 documents, up 27.6% from the previous year.

Weekly Clinic: This program has an amazing return on investment. We pay

three staff attorneys and two support staff to run the clinic; the cost for the three hours is about \$465. We recruit six to eight volunteer attorneys and the same number of law students to help. If attorney time is calculated at a moderate \$200 per hour and student time at \$20 per hour, we are providing a \$7,080 value for \$465 each week. In 2022 we served 1,986 clients through this program, a 34.6% increase from the prior year.

Community Clinics: We set up clinics across the state where clients can meet with local volunteer attorneys or TLC attorneys online. This allows us to connect our services with communities throughout Utah that traditionally have less access to legal services than those along the Wasatch Front. This program grew by an impressive 149% last year. During COVID, many of these clinics were shut down. Our staff has been concerned about the impact this had on individuals in rural areas. We are encouraged by the work we've been able to do with our partner service providers throughout the state, and we look forward to expanding this program in 2023.

Pro Se Calendar:

TLC helps several judicial districts in Utah to facilitate their Pro Se Calendars. At these calendars, we provide volunteer attorneys to clients with the goal of reaching an agreement before the case is set for trial. This program is still being re-built after COVID as the courts continue to work through their dockets. We look forward to having more established calendars in 2023. In 2022, we were able to serve 14 clients through this program.
