Cont'd from Page 2: Thanks to our strong team of managers, we maintained a remarkable 97% voluntary retention rate and high levels of satisfaction, with scores like "My manager creates a trusting and open environment" receiving an impressive quarterly average of 4.8 out of 5, and "I would recommend Rivet School as a great place to work" achieving a noteworthy quarterly average of 4.7 out of 5, with a 100% response rate each quarter. Over 2024, we expanded our presence into two new communities - Chicago and New Orleans - and made strategic investments to create new pathways to college for recent high school graduates and for working adults in the healthcare sector. This multi-faceted growth strategy is already yielding results: we enrolled over 400 fellows throughout 2024. Referral partnerships with employers, K-12 schools, and CBOs continue to be one of our most consistent and effective strategies to find, recruit, and enroll Rivet School fellows, driving more than 100 of our 287 new enrollments in 2024. Our Growth team generated over 3,400 leads in 2024, and our Admissions team set new records this year by confirming 69 fellows for our September Onboarding group and 54 for our November Onboarding group - a significant increase from our average of 36 Onboarding starts per deadline in 2023. A majority of these fellows are successfully completing Onboarding and enrolling - our average retention from Onboarding through to successful enrollment is up to 65%

in 2024 compared to 57% in 2023. As of 12/31/24, Rivet School had served 744 students, with a total composite of 469 enrolled students (including Onboarding, Active, and Paused). Over the summer, our team proudly reached a significant milestone with the graduation of our 100th BA fellow. As of 12/31/24, we've conferred 106 AA degrees and 134 BA degrees. Among graduated students, our median time to a BA degree is 2.6 years. 75% of our graduates have secured a "strong job" (either a full-time job (32-40 hours/week) at an annual salary of \$61,871 or higher, with employer-provided paid time off and/or health benefits, or enrolled in a graduate program or fellowship requiring a BA degree.
