Our founding degree partner is Southern New Hampshire University, which offers a program called College for America, or CfA. Through CfA, enrollees earn their Associates of Arts or Bachelors of Arts degrees. In 2025, we continued executing on our ambitious strategy to grow and enroll 800 students annually by EOY 2026. We built on our past successes by exploring opportunities in our newest regions (Chicago and New Orleans), expanding our employer partnerships and programming (Educator and Healthcare Pathways), and refining our team's capacity to maximize outcomes for our students and graduates. After exercising due diligence, the governing board or committee shall determine whether the organization can obtain with reasonable efforts a more advantageous transaction or arrangement from a person or entity that would not give rise to a conflict of interest. If a more advantageous transaction or arrangement is not reasonably possible under circumstances not producing a conflict of interest, the governing board or committee shall determine by a majority vote of the disinterested directors whether the transaction or arrangement is in the organization's best interest, for its own benefit, and whether it is fair and reasonable. In conformity with the above determination, it shall make its decision as to whether to enter into the transaction or arrangement. Violations of the Conflicts-of-Interest Policy: If the governing board or committee has reasonable cause to believe a member has failed to disclose actual or possible conflicts of interest, it shall inform the member of the basis for such belief and afford the member an opportunity to explain the alleged failure to disclose. If, after hearing the member's response and after making further investigation as warranted by the circumstances, the governing board or committee determines the member has failed to disclose an actual or possible conflict of interest, it shall take appropriate disciplinary and corrective action.

Cont'd from Page 2: This multi-stage growth strategy is yielding results: 2025 was a record-breaking year for our Growth team and a clear signal that Rivet School's model is resonating with learners and partners alike. Across the year, we generated more than 4,200 prospective learner leads – nearly 1,000 more than in 2024. Over 1,800 of those leads came directly through partner referrals, while more than 2,000 were driven by our marketing efforts, including a growing presence on Instagram and TikTok. We welcomed our largest onboarding cohort to date, admitting 89 fellows for our fall term, and we enrolled 550 students throughout the year, putting us within striking distance of our big goal. A defining feature of our program work in 2025 was a much more rigorous and intentional use of caseload data to drive student success. This orientation was a key driver of our success this year. 2025, more than 70% of fellows earned eight or more credits – the baseline we defined for meaningful degree progress – and 81% of students earned a BA degree in 3 years or less. Prior to 2025, an average of just 53% of fellows met this threshold each term. In the fall, we hosted our largest BA graduation to date, celebrating more than 50 graduates who earned their bachelor’s degrees this year. As a team, we also marked a major organizational milestone: our 200th BA graduate. We also continue to achieve robust career outcomes: within 9 months after graduation, 73% of our alumni had secured a “strong job” (either a full-time job at an annual salary of \$63,700 or higher, with employer-provided paid time off and/or health benefits, or enrolled in a graduate program or fellowship requiring a BA degree). Finally, thanks to our strong team of managers and intentional culture-building, our organization maintained a 95% voluntary retention rate and high levels of satisfaction, with scores like "I am satisfied with the progress we're making as an organization" receiving a 4.5 out of 5, and "I would recommend Rivet School as a great place to work" achieving a 4.8 out of 5, with a 100% response rate each quarter.
