Letter From the CEO

Dear Supporters,

What a year it has been, and what a year it will be.

The young people we serve continue to come from some of our city's most vulnerable communities. Those most affected by economic hardship, inequity, and broader social challenges. Today, 97% of our students qualify for free or reduced-price lunch, and 96% are students of color. A powerful reminder of why our mission to provide consistent guidance, opportunity, and hope remains more important than ever.

On behalf of the board of directors, staff, and community we serve, thank you. We are deeply grateful for the support from our partners, donors, funders, and volunteers and remain dedicated to responsible stewardship. In 2025, we managed \$2.74M in revenue and \$6.69M in total assets, allowing us to continue vital programs while planning for the future.

However, we are becoming increasingly aware of the impact of lowered school enrollment and federal education funding on our co-founder Denver Public Schools. We know uncertainty in funding is coming our way. Even so, we will not waiver in our work and support of students. Our audit shows that 74% of our funding goes directly to programs, and we will continue to ensure our funding is directed to student programs and supports. Our ability to thrive amid uncertainty speaks to the collective strength of our community.

Despite all that goes on, Denver Kids had one of our most successful years in our history. We are celebrating a 94.8% on-time graduation rate and 81% of 2025 graduates are pursuing postsecondary education or are enrolled in the Gap Year track in the Denver Kids Youth Pathways Postsecondary Program. We are very proud of the Class of 2025!

We look forward to celebrating graduates like Jenny. Jenny is a Junior at KIPP Denver Collegiate High School and just completed the Medical Career Collaborative Internship at Denver Health. She has aspirations of attending medical school to become a doctor. Her Advisor, Arnoldo, says, "Jenny is a very intelligent young lady. Part of our social-emotional learning meetings have centered around finding intrinsic motivation and developing a strong sense of self and confidence."

Looking ahead, we remain committed to supporting students as they chase their dreams. Together, we'll keep building a stronger community and shaping bright futures for Denver's young people. Thank you for being part of this journey.

Who We Serve

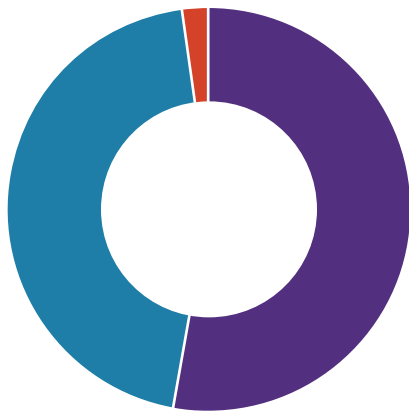
Of the more than 90,000 students enrolled in Denver Public Schools (DPS), **62.6% are Free/Reduced-Price Lunch Eligible (FRL)**, an indicator of poverty.

For young people who are experiencing the challenges of higher risk environments, outside factors often create roadblocks to their academic success and social-emotional wellbeing.

At Denver Kids, our model is a promising solution to counteract the challenges of poverty and the effects of stress and childhood trauma.

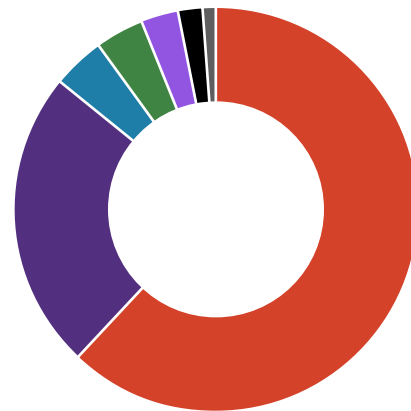
2024-2025 Denver Kids Student Demographics

Students' Gender



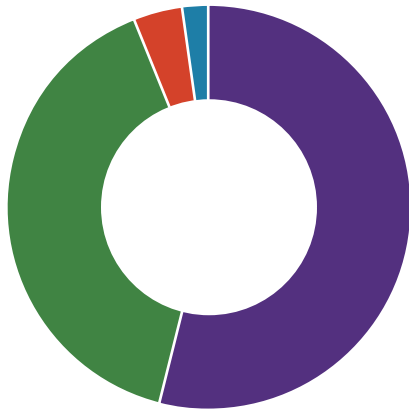

Students' Race/Ethnicity



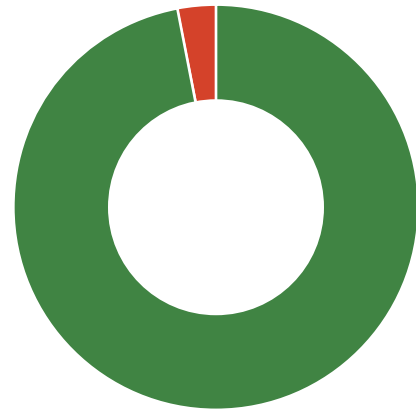

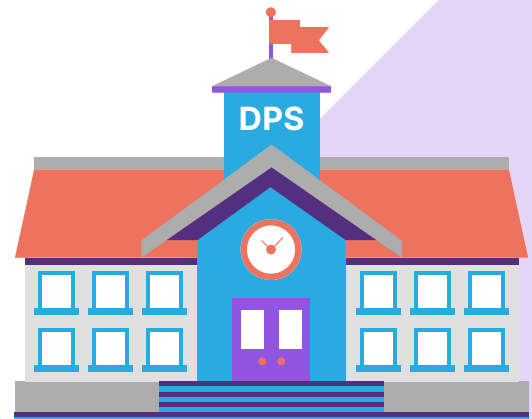

Where We Work

In the 2024-2025 school year, Denver Kids provided wrap-around support to **908 students in 70 district schools** and **38 graduates pursuing various postsecondary plans**, including two- and four-year colleges, trade schools, gap years, and employment. Our work helped improve attendance, respond to critical student needs, reduce discipline referrals, and increase graduation rates.



Our Approach

Denver Kids believes it takes academic support, enrichment, social-emotional tools, and future planning to unlock full, lifelong success for every student. Simply offering **one** or **some** of these elements isn't enough. Our students need—and deserve—the aggregate power of **all** of these supports. Our model, proven for nearly 80 years, is differentiated by strategically creating, and constantly evolving and improving, a holistic experience that supports young people as individuals, students, and future leaders.



Programmatic Elements

Denver Kids programming is student-driven, comprehensive, and proven effective for nearly 80 years. Students are provided one-on-one support during their entire time in Denver Kids, which, on average, is five years for Denver Kids graduates.



One-on-One Advising

Relationship-driven support provided by long-term, trusted, expert Advisors.



Social, Emotional and Academic Learning (SEAL) Tools

Infused throughout everything we do, with benchmarks and measures to ensure efficacy and continued improvement.



College and Career Readiness

Helping students explore a myriad of opportunities after high school, including college, technical training, and career options.



Postsecondary Programming

Supporting Denver Kids graduates in their first year of postsecondary transition as they pursue education and career opportunities.



Enrichment Experiences

Connecting students to opportunities that stoke their curiosity and embolden their dreams.



Mentorship

Volunteer mentors serve as another role model and cheerleader as students reach for their future goals.

Our Mentor Program

Denver Kids pairs qualifying students in our program with adult volunteer mentors for a minimum of one year. Mentors work closely with a student’s Advisor to position the student for success by addressing their unique goals and challenges.

66 volunteer mentor matches, with mentors spending an estimated 5,664 hours with our students.

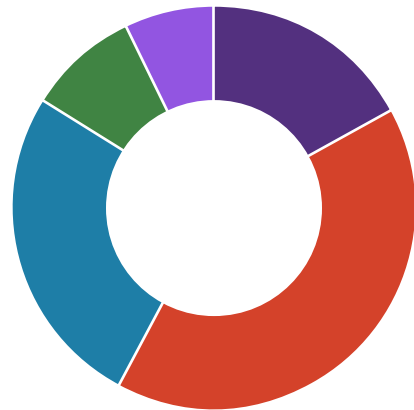
2024-2025 Denver Kids Mentor Demographics

Mentors’ Gender



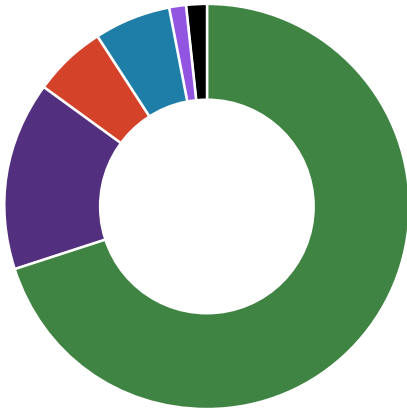

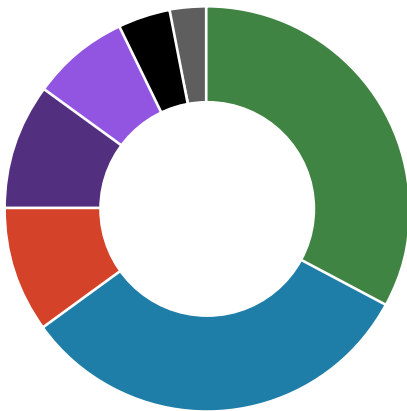
Financials

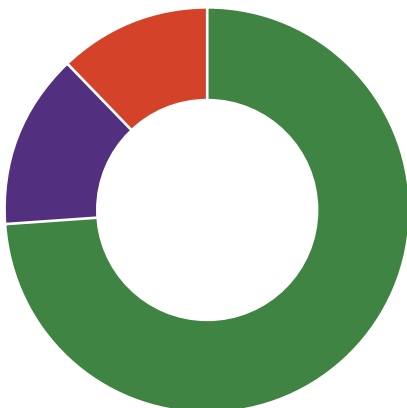
Denver Kids drew from its operating reserves to address the revenue shortfall and maintain programs and services.
