Alma D. Green

Victor H. Green, a Harlem postal worker, founded and published the first “*Negro Motorist Green Book*” in 1936. This was an annual, vital travel and survival guide from 1936 through the 1960s to help African American travelers navigate segregation, Jim Crow laws, and sundown towns. He died in 1960. His wife, Alma Green, managed the publication until it began to wind down following the passage of the Civil Rights Act of 1964, which prohibited racial segregation in public accommodations.

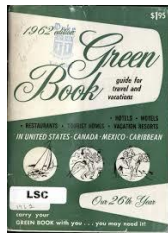
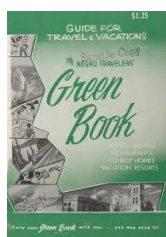
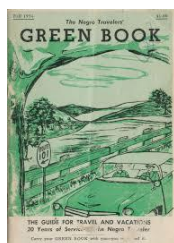
