### RESOLUTION NO. 2025 11-01

# A RESOLUTION OF THE TIPPECANOE AND CHAPMAN LAKES REGIONAL SEWER DISTRICT MAKING A PURCHASE OF EQUIPMENT PURSUANT TO INDIANA CODE § 5-22-10-8

**WHEREAS**, the Board of Trustees (the "**Board**") of the Tippecanoe and Chapman Lakes Regional Sewer District (the "**District**") has been duly established and is authorized to transact business pursuant to IC 13-26, *et seq.*;

**WHEREAS**, the District requires certain equipment in connection with the East Webster project, as set forth in Exhibit A attached hereto (the "Equipment");

**WHEREAS**, the Board, as the purchasing agent, is required to procure goods and supplies pursuant to IC 5-22 *et seq.*;

WHEREAS, IC 5-22-10-8 provides that the purchasing agent may make a special purchase when the compatibility of equipment, accessories, or replacement parts is a substantial consideration in the purchase; and/or only one (1) source meets using the agency's reasonable requirements;

**WHEREAS**, a purchasing agent engaging in special purchasing methods must maintain contract records for a minimum of five (5) years, containing certain information in accordance with IC 5-22-10-3, substantially in the form as Exhibit B attached hereto;

**WHEREAS**, the Board desires to make a written determination and record the necessary information to engage in a special purchasing method for the provision of the Equipment.

#### NOW, THEREFORE, BE IT RESOLVED, THAT:

- 1. The District hereby determines that the compatibility of equipment, accessories, and replacement parts is a substantial consideration in the purchase of the Equipment and/or only one (1) source is licensed to sell such Equipment in Indiana.
- 2. Upon approval of the District, Jones Petrie Rafinski Corp., or other contractors that may be hired by the District, are authorized and instructed to proceed with all matters and to execute all documents or instruments necessary or required to complete the special purchase of the Equipment as contemplated herein.
- 3. This Resolution will be in full force and effect upon its adoption by the District.
