Background

Pancreatic cancer is a multifaceted disease that demands treatment and management from a variety of sectors in the healthcare field, with additional strong networks between healthcare providers and foundational researchers. Many of the unique challenges associated with pancreatic cancer precipitate from late-stage diagnosis, molecular and cellular heterogeneity, and several morbidities that largely derive from malnutrition. As reviewed by Grossberg in 2020, a multimodal approach that integrates improved screening, targeted/precision medicine approaches to treatment (including in the palliative setting), and holistic management of symptoms has proven to increase metastasis-free survival and quality of life[1].

Advancements in treatment options for pancreatic cancer have not kept pace with those for other cancers[2], but efforts continue to adapt, develop and combine approaches to effect change in the difficult-to-treat cancer.

Guidelines for Presentations

- Title should be readable 10 feet away
- Title is short and draws interest
- Poster Board should be 3ftx4ft
- Acknowledgments
- Your name
- Institutional affiliation
- References and/or Acknowledgments (Funding Acknowledgement, using the Specific Name of the Award)
- References cited in APA format
- Written permission from the owner to include any copyrighted material in the published form of your poster.
- Information organized
- Headlines
- Consistent and clean layout
- Clear and to the point
- Short sentences
- Grammatically correct
- Content
- Abstract or Background
- Introduction and/or Objectives
- Methods, Results and Conclusions
- Future Work, References and/or Acknowledgments.
- Text
- Font large enough to read
- Technical level appropriate for the audience
- Requires no further explanation from presenter
- Visuals: Visually appealing and not cluttered, effective use of tables, graphics, data, color, drawings, photos
- Fonts sizes/variations which facilitate the organization, presentation, and readability of the research
