- Be accepted to an institution of higher learning.
- Graduated from high school or graduating within 9 months or in lieu, have received GED or are receiving GED within 9 months.
- A two to four-year college student enrolled in a US-institution for undergraduate or graduate studies.
- Employees and vendors of Hancock Injury Attorneys and immediate family members are not eligible for this essay contest.

- One to Two Page essay, 500-800 words on one of the following topics:
 - Create an innovative solution to decrease the number of accidents in Florida (over 400,000) every year.
 - On July 1, 2019, Florida made texting while driving a primary offense. Do you think that this change will be effective? What are other things Florida can do to curb distracted driving?
