## Hard Words

**Microchip:** An electronic device that is capable of being permanently implanted in an animal of a prescribed class of animal and that is designed to record information in a manner that can be electronically retrieved.

**Dangerous Dog:** A dog which has been declared to be dangerous by a Council under Part 3 of the Domestic Animals Act or a dog which by virtue of the operation of section 34A of the Domestic Animals Act is a dangerous dog.

**Menacing Dog:** A dog which has been declared to be a menacing dog by a Council under Part 3 of the Domestic Animals Act.

**Sterilised:** A dog or cat that has had a surgical procedure to remove all or part of the reproductive organs to prevent it breeding.

**Farm Working Dog:** Your dog must herd, drove, protect, tend or work stock on land used solely or primarily for primary production.

**VCA:** Victorian Canine Association operating as Dogs Victoria.

**Approved Person:** A Statutory Declaration can be witnessed by a Justice of the Peace or Police Officer above the rank of Sergeant: Oaths and Affirmations Act 2018.

**Restricted Breeds:** Pit Bull Terrier, American Pit Bull Terrier, Fila Brasileiro, Dogo Argentino and Japanese Tosa

**Applicable Organisation:** Australian National Cats Inc, Cats Victoria Inc, Dogs Victoria, Feline Control Council (VIC) Inc. and The Governing Council of the Cat Fancy Australia Inc.

**Statutory Declaration:** A statutory Declaration is sometimes called a 'stat dec'. A Statutory Declaration is a legal document and means you are telling the truth.
