The Story of Christina and Maria

Christina and Maria were just 6 and 8 years old when they were removed from their mother's care after experiencing physical and emotional abuse due to her severe mental illness. The girls have dual British Lithuanian nationality, and although they had regular Skype contact with their father in Lithuania, he indicated that he was unable to care for them permanently. There was no family left to care for the girls in the UK, and so they ended up in the care system.

Thankfully, the children's local authority asked CFAB to assess the possibility of Christina and Maria being cared for by their paternal aunt and uncle, who lived in Lithuania. We used our worldwide network to contact our ISS partner in the country, who was able to complete a positive assessment of the family.

Following CFAB's assessment, the girls were placed in the long-term care of their aunt and uncle. The UK local authority then requested CFAB conduct post-placement visits via their ISS partner to ensure the girls settled well into their new family life.

We are experts in social work in an international context, cross-border child protection cases, care proceedings requiring cross-border cooperation and overseas placements. We specialise in understanding UK local authority processes, international legislation and placements.

Our position in the ISS network gives us unrivalled access to expert, on-the-ground support, allowing us to assess whether a child's return to their heritage country is realistic and in their best interests. This is more effective, cost-efficient and safer than sending social workers from the UK to undertake assessments on foreign soil. Our expertise is not limited to ISS countries - we have built extensive knowledge through our experience in working on cases across the world.

A child is in the care of a local authority. The local authority becomes aware that the child has a grandmother in Canada and so contact the CFAB Advice Line.



The local authority refers the case to CFAB. CFAB contacts our ISS partner in Canada and shares information provided by the local authority social worker.



Our ISS partner in Canada conducts a kinship assessment of the grandmother and the local environment and returns the assessment to CFAB.



Using evidence from this assessment the UK court decides that it is in the best interests of the child to be reunited with their grandmother.



At the request of the court and local authority, CFAB arranges for post-placement visits to be conducted 6 and 12 months after the reunification.

Our Services

International Child Protection Alerts

Reporting child protection concerns to child welfare organisations abroad within 24 hours.

Record Checks

Requesting and receiving social services records and information from authorities abroad.

Welfare Checks & Home Visits

A visit by an overseas social service professional to the family home, usually to ascertain the safety and welfare of the children and their living circumstances.

Full Assessments

Requesting and obtaining assessments from our partners overseas. *Including kinship, parenting and best interest assessments.*

Court Advice Service

Representation of a child as their guardian in the courts to ensure decisions protect the child and are in their best interests.

Best Interests Assessments

Assessments to assist asylum and family unification applications involving children. Exclusively for sponsors already living in the UK.

Immigration Advice Service

CFAB is accredited to provide Immigration Advice Authority (IAA) Level 1 services and support to refugee and migrant families.



Local Assistance

An in-country social service professional accompanying and assisting a UK social worker to understand local culture, context, regulations and support services, when visiting overseas, to inform a final care decision.



Pre-placement Preparation

Direct support to prepare the family ahead of the arrival of the child.



Post-placement Support

Welfare visits to confirm the child's health, safety, routine and development in their new family environment.



Life Story Work

Direct support for the child to help them process their feelings, come to terms with their circumstances and develop a clear sense of identity for the future.



Virtual Contact Supervision

Multi-lingual supervision from a qualified social worker to ensure safe, positive contact of children with a non-resident family member via an online platform.



Family Reunification - in the UK

Practical and emotional support for young refugees reunited with family members in the UK.



Family Group Decision Making Support

CFAB provides advice and support to local authorities to meet their statutory requirement, under the Children Schools and Wellbeing Bill 2026.

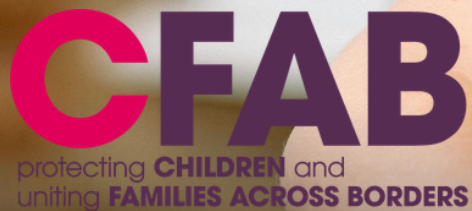
