Engagement Assessment

Project Descripton

This project is a major component of Crockett's Recover the Waterfront vision. This funding helps create a community park and green space within view of the Carquinez Strait. The site is currently an abandoned area held by the California State Lands Commission (CSLC) and informally adopted by the Recover the Waterfront group. The park, along with its sole access road, are designed to incorporate native plants within bioswales and rain gardens, a parking lot with permeable surfaces, native tree planting and a freshwater wetland. This waterfront will provide a common use space for activities such as picnics, relaxation, community gatherings, and recreation staging, as well as connections to preexisting infrastructure including open space, the Bay Trail route, the Carquinez Strait waterway, the Carquinez Bridge pedestrian/bike path, the Carquinez Trail loop, non-profit volunteer facilities, and under-bridge plantings.

Planning Stage Outreach Activities (Completed):

- Kick off meeting with Carquinez Recover the Waterfront Committee (CReW), a group of local agency, business, inductry and community stakeholders created in 2018 to assess viable projects at the Crockett Waterfront
- Field trip/site tour opportunity for CReW Committee

- Conducted 4 Public Participation Workshops to analyze existing conditions and generate ideas for what elements should be included in the park master plan including small group discussions

Roles and Responsibilities

- CCRCD Staff work with consultant, CReW and the community to develop the master plan to
 present to the Contra Costa County Planning Commission, ensure the effectiveness of the
 public participation process, provide review and recommendations to the ultimate decision
 makers in accordance with established county policies and plans, keep community informed
 about progress of the plan through legal review process
- Consultant work with staff, CReW and the community to develop the master plan, record and honor public input, communicate how public input has shaped decisions about the plan, present master plan to the Planning Commission to start legal review process
- CReW Committee work with all stakeholders and local organizations to ensure public input is accurately included in Master Plan
- Planning Commission review Master Plan, work with staff to resolve outstanding issues, hold a public hearing to gather community input, make a recommendation to the Board of Supervisors
- State Lands Commission review Master Plan and Planning Commission recommendation, work with staff to resolve any outstanding issues
- Board of Supervisors review Master Plan and Planning Commission recommendation, work with staff to resolve any outstanding issues, hold a public hearing to gather community input, vote to adopt the Master Plan

Gather and Disseminate Input and Results

The plan will ensure dissemination of public input to decision makers and back to the public at large to demonstrate how comments and concerns have been recorded and understood and accurately communicated. It will also show the public how their input has been translated and how it influenced the outcome of the project.

- The CCRCD website will be kept up to date on all meetings and other events
- All comments generated at public meetings will be recorded and available for review on the CCRCD website and will be available for decision-makers during their review
- Major revisions to the plan will be communicated to the community prior to being presented to either the Planning Commission or the Board of Supervisors
- All information will be shared on the CCRCD social media sites periodically
- Community email list will be updated regularly to keep interested citizens up to date
- Press releases and other materials will be sent out as appropriate to keep the community informed about the progress of the project

- A community open house will be held in Crockett as the plan moves from the preliminary to the final design stage
- Copies of Vision Plan and Master Plan will be available at local libraries

Evaluate Effectiveness

We will use evaluation as an ongoing tool to assess and improve the public participation plan as the project moves forward, including the following strategies:

- Informal feedback
- Questionnaires/surveys
- End of project evaluation to see if goals are met will reassemble the Master Plan Committee for this purpose
