NRCS REPORT: Luis Rivera-Cruz presented updates on fiscal year-end contracts and a rise in the number of applications. 8.1 Consider approval of contracting Civicorps for vegetation management of Little Frank's Tract.

Ben Weise presented an overview of the proposed vegetation management work at Little Frank's track, including the scope of services Civicorps will perform and the funding source.

Heidi Petty presented the proposed agreement to host four California Climate Action Corps Fellows through Bay Area Community Resources. The fellows will serve a 11-month term supporting the CCRCD.

Motion: Walter Pease moved to approve the agreement with Bay Area Community Resources for placement of four fellows. Bethallyn Black seconded the motion. Motion carried 4:0.

8.4 Consider approval of agreement with C & H Sugar Company, Inc. for the Crockett Shoreline Flood Mitigation project funded through the Crockett Shoreline Flood Mitigation Supplemental Environmental Project (SEP).

Heidi Petty explained the Supplemental Environmental Project (SEP) funding and the goals relating to the Crockett Shoreline Flood Mitigation, clarifying S&H Sugar participation.

Motion:, Bethallyn Black moved to the agreement with C & H Sugar Co. Walter Pease seconded the motion. Motion carried 4:0.

Lorena Castillo—Lorena Castillo announced that Groundwork Richmond will host an Arbor Day event on October 18th from 9:00 a.m.-1:00 p.m. Lorena Castillo suggested CCRCD consider tabling at the event.

Tracey Rogers Brandt shared a tabling opportunity at the upcoming San Francisco Bay Delta Bioregional Regeneration, Saturday, October 4, 2025 from 9:00 a.m. to 5:00 p.m. at Laney College, Oakland, CA.

10.4 Executive Director Reports—Chris Lim provided updates on staffing and highlighted developments in the Bay Point project, including concerns about groundwater intrusion and the nearby property for sale. Chris Lim also discussed the presence of the Henkel facility in the area and their expressed interest in supporting community projects. Chris Lim concluded by announcing that Proposition 4 funds have been reinstated and outlined several potential projects that are preparing to submit funding requests.
