- TEX Project—accepted into Fall 2025 cohort!
 - The state of our project idea, next steps, determining project scope, reaching out to FOPCW for advice
 - Evan briefed those new to project on where we stand
 - Igor offered to show folks sites of landslides and gullying
 - Strezel Valley an example of landslides
 - Igor know other similar sites

 - Evan relayed results of quarterly meeting with CDFW—Cutting the Green Tape
 CDFW staff recommended 1602 Notification, not HREA
 - Would not be getting benefits of HREA (CESA take permitting, 401 Cert from Water Board)
 - Evan to check
 - Another step of consultation necessary with CDFW?
 - Double check with CDFW to see if ok for FOAC to apply for 1602
 Notification
 - Bob to be lead on writing the LSA 1602 Notification
- Planning for future requests for projects
 - Mitigation projects
 - Supplementary Environmental Projects (SEPs)
 - Developing and organizing Project List
- Vegetation Management between Escobar and Main (behind Roxx on Main)
 - How to facilitate this work with City and CDFW
 - Jamie and Elaine suggested that our strategy be to work on the Arundo control effort, separate from this
 - Idea would be to use up the MRC funding, potentially get more next season
- LACWMP implementation facilitation
- Igor mentioned Shanell Scales-Preston offering money
 - o Evan to send this out to group
 - Jamie mentioned that community meetings have already been happening related to this funding
