 - Developing Project Description
 - The group discussed keeping the TEX discussion at future AWC meetings to just brief updates, having most of the discussion outside of the meetings
 - Suzy gave updates on project progress
 - Put out request to group for cover photo for TEX page
 - Elaine and Doug to look for good photos
 - Jamie showed a photo of Alhambra Creek showing recent erosion, potentially a slump near her house
 - Trevor Rice mentioned that NPS has a decent stock of monitoring photos of the Creek
 - Also mentioned that NPS geomorphologist John Wooster suggested that NPS install creek erosion pins, this is in the works
 - Mitch suggested we resend the TEX project scope out, have everyone take a look at it, get comments back by early next week (or maybe next wednesday?)
- Arundo removal project—permitting process update (Bob Huttar/Jutta Burger)
 - Issue of planting - developing plant list for landowners? Folks are already asking about replanting
 - Monitoring - is this something we want to train landowners to check (checking for sprouts)
 - Igor mentioned that Bob Huttar, lead on the Arundo effort, will be presenting to Kiwanis Martinez on Arundo control on Jan 22 at 12:00
 - Bob is bringing a stalk of Arundo to share!
 - Noah Luecke mentioned that he works for CC County on Arundo control, asked what our methods are
 - Jamie gave a description of FOAC's methods
- Local Community Benefits Fund (Benicia, Richmond)—what did we learn from the informational webinar on 10/29?
 - Evan to reach out to Brianne about this
- Planning for future requests for projects
 - Mitigation projects
 - Supplementary Environmental Projects (SEPs)
 - Developing and organizing Project List
- Vegetation Management between Escobar and Main (behind Roxx on Main)
 - How to facilitate this work with City and CDFW
 - Mitch talked to Trevor McGuire
 - Do not have CDFW permit yet
 - City has applied for it, are waiting for funding
 - Want to get funding for sediment removal and vegetation management at once, want to do one project not two
