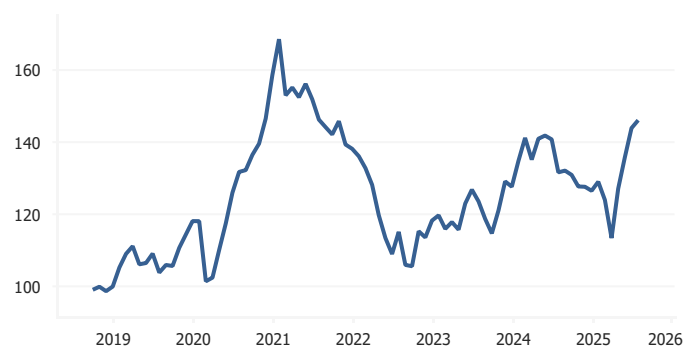

DESCRIPTION

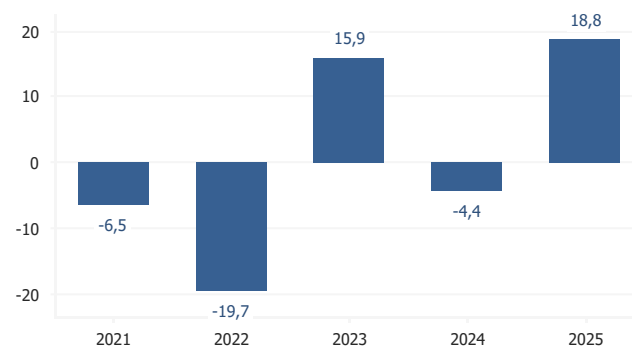

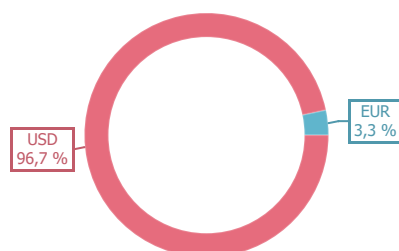

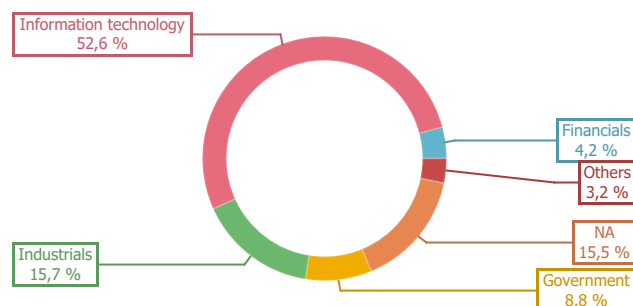
Net Currency Exposure



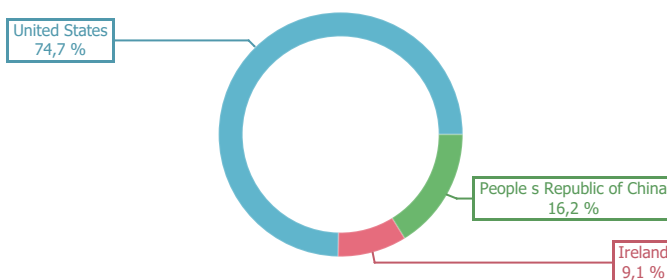
Asset Allocation
