Item: Tomorrow's Tour - Concert Series

The Tomorrow Tour, an initiative offered through Tomorrow's Towns Program, is getting ready to be launched in October with a concert series that will travel to communities across the province. Each month will feature a different artist, and communities will be asked to provide the venue and one night of accommodation for the artist. Town Clerk Lorne Greene and Economic Development Officer Amy Tiller are scheduled to meet with Tomorrow's Towns Program Coordinator Rudy Norman on September 17th, 2025, to discuss this event.

Item: Lift Station Upgrades – Scope Change

The scope change request for Lift Station Projects 17-GI-24-00004 and 17-GI-24-00093 have been approved with a new budget of \$355,107.24 for each lift station.

Item: Tomorrow's Towns – Food Security Opportunity

Through Tomorrow's Town, there is work being completed with the Food Producers Forum to highlight funding that is available to build earth-sheltered greenhouses. These greenhouses combine the tradition of a root cellar with modern design, using the earth for insulation and solar energy for heat resulting in fresh, healthy food grown locally all year. There is no interest in this program.

Item: Removal of Boil Water Advisory

The Department of Government Modernization and Service Delivery recommended the removal of the Boil Water Advisory in correspondence dated August 15th, 2025.

Item: Gander Area Community Development Corporation

The Gander Area Community Development Corporation is seeking community and business-minded people to serve on their Board of Directors. As a volunteer director, an individual would be a part of a team that directly impacts the community by supporting business development and rural job creation. There is no interest currently.

It was noted that the tent would not be on the Village Green at that time so; therefore, the adult dance would not be able to proceed. It was discussed to forward the Village Green Rental Policy to the organizer and advise that a list of planned events would be reviewed once the agenda has been finalized.

Item: Violence Prevention Gander - Signage Request

There was correspondence received on behalf of the Violence Prevention and Area, in partnership with the Gander Women's Centre requesting permission to place temporary signage on Gambo's walking trail during Sexual Violence Awareness Week (September 15th - 19th, 2025). Item: Cal LeGrow – User Groups Liability Policy

There was correspondence received from our insurers relating to the rental of town facilities. It was noted that the Town's policy only covers town operations and does not provide liability protection for people or groups using town facilities. Anyone renting a town facility would need to have their own liability coverage in place to be protected against a claim/legal action being brought against them if they caused, or alleged to have caused, bodily injury or property damage to others arising from their activities. It is recommended that anyone using town facilities be required to provide the Town with a Certificate of Liability Insurance with a limit of coverage not less than \$2,000,000 with the Town added as an additional insured. Our insurers offer a User Group Liability Program with a minimum retained policy premium of \$2,500. It was discussed that it would not be financially feasible to purchase this policy based on the small number of facility rentals each year.

Gambo Fire Department:

- A Moose Burger sale is being planned for the fall. The Department is still awaiting information about this year's moose license.
- The computer on the transmission of the fire truck has been replaced.
- Three Members have resigned with three new members ready to begin.
- Councillor Burry discussed the Fire Smart Program indicating that spring would be a good time to participate in the program.
- Five Members from the Department attended the Kingston Fire. A letter of thanks from the Premier and Minster Haggie was received. There were thirty-five departments involved in fighting the fire. There was an email received requesting a list of damaged equipment from the firefighting efforts and a claim has been submitted for damaged hoses and boots. Further, six sets of Wild Land Coveralls were donated to the Department.

SEDCOR:

- Council thanked Councillor Burry for his service on SEDCOR.
- Councillor Burry expressed his satisfaction that, although most members of the SEDCOR Board are not originally from Gambo, they have shown great enthusiasm in adopting the community as their new home and have willingly volunteered their time to support its growth.

- He noted that a Board Meeting is scheduled for this week.

- It was noted that there is a broken board on Middle Brook Trail.

Town Clerk's Report:

- The closing date for the sale of the Smallwood Interpretation Centre has been moved to October 1st, 2025.
- We had sewer issues at 25 Holland's Road, and I have the matter assigned to our insurers.
- John and Lucy Glennon were here on August 18th, 2025, for a reception. They were biking the Trailway raising monies for the Ronald McDonald House Charities.
- Municipal Approval was granted for five Fire Department Members to aid in the firefighting efforts with the fire in Kingston. A big thank you to the Fire Department.
- John Baird, Municipal Planner and I met with a developer regarding an upcoming development.
- I had a meeting with a resident regarding the enforcing of dogs on leashes on the Middle Brook Trail. He wants to know if it will be enforced or not.
- There was a lightning incident at the Smallwood Interpretation Centre. The garage sustained damage. I am currently working with Newfoundland Power on this matter, and they will be repairing the property damage. A contractor will be assessing the damage today.
- We have recently received funding under the Community Enhancement Program. I have advertised three times and have not received any applications.
- We held a meeting with the current operators of the David Smallwood Park on August 19th, 2025.
- We held a meeting with a resident regarding a business application. I have received confirmation from the Municipal Assessment Agency that it is possible to combine both parcels of land as requested.
- I have spoken with Lori Mercer, Auditor, and she will be here on September 17th, 2025, to meet with Council to discuss the 2024 Financial Statements.
- I have contacted Newco Metals regarding the metal pickup and have been advised that the equipment will be on-site within five to six weeks for collection.
- In the Budget for 2025, I had included the painting of the foyer of the Town Office. Our Utility Staff have told me that the office will need to be closed for a couple of days as they have to use scaffolding. I will need permission for this.
- The repairs to the Gambo Community Youth Centre have begun and I have been advised by the contractor that the repairs will not be completed until sometime in November.
- The Limited Call for the Consultant Fee Request for the Street improvements Project for Smith's Road has been issued with a deadline for proposals for today, September 8th, 2025. I have been advised that we can utilize Gas Tax Funds for Council's portion of this project.

- The Water Intake Extension Project has an issue with the intake extension. The contractor has provided an estimate in the amount of \$81,305.00 and there are insufficient monies remaining in the project to cover this.
- The re-assessment report for the patio for the Smallwood Interpretation Centre has not been completed yet. The Department is awaiting the scope of work that is required to ensure compliance with the DFA Program before proceeding.
- The Prime Consultant Agreement was signed on August 28th, 2025, with Cecon Ltd. for the road repair under the DFA program and they have until September 18th, 2025, to have the assessment report submitted to the Department for review
- The three lift stations in the first project are up and running with a few items left to complete. The commissioning of all three stations will take place on Thursday, September 11th, 2025.
- It has been confirmed in MSIS that the Lane's Road Street Upgrades Project has been rejected.
- The next Regular Meeting will be on September 29th, 2025.
