



### **AbbottWMM 2026 Race Draws Terms and Conditions**

1. The Promoter of this prize draw is World Marathon Majors LLC of 21660 W Field Parkway, Deer Park IL 60010 ("WMM").
2. These terms and conditions (these "**Terms**") apply to the draws for places in the 2026 TCS SYDNEY MARATHON, 2026 BMW BERLIN-MARATHON, 2026 BANK OF AMERICA CHICAGO MARATHON, 2026 TCS NEW YORK CITY MARATHON, 2027 TOKYO MARATHON, 2027 BOSTON MARATHON PRESENTED BY BANK OF AMERICA and 2027 TCS LONDON MARATHON.
3. Entrants must claim their entry into the draw through the Runner Portal by the due date published in the Race Draws section of the WMM website.
4. Subject to condition 8 below, the prize draws for entries in the 2026 Sydney, Berlin, Chicago and New York City Marathons are open to all individuals registered with [worldmarathonmajors.com](http://worldmarathonmajors.com) who have completed three, four, five or six WMM races prior to the draw taking place, but have yet to complete their fourth, fifth, sixth or seventh WMM race (respectively).
5. Subject to condition 8 below, the prize draws for entries in the 2027 Tokyo and Boston Marathons are open to all individuals registered with [worldmarathonmajors.com](http://worldmarathonmajors.com) who have completed fourth, five or six WMM races prior to the draw taking place, but have yet to complete their fifth, sixth or seventh WMM race (respectively).
6. Subject to condition 8 below, the prize draw for places in the 2027 London Marathon is open to all individuals registered with [AbbottWMM.com](http://AbbottWMM.com) who have completed three, four, five, or six WMM races prior to the draw taking place, but have yet to complete their fourth, fifth, sixth, or seventh WMM race (respectively).
7. Subject to condition 8 below, runners who have already completed all seven Abbott World Marathon Majors races are not eligible for these prize draws.
8. Runners that are current members of the AbbottWMM Gold Club are eligible to participate in the general prize draw, but must still meet the eligibility criteria outlined in conditions 4-7 above. Runners that are current members of the AbbottWMM Gold Club are also eligible to participate in separate prize draw designated for Gold Club members only that does not require that the eligibility criteria outlined in conditions 4-7 above are met.

9. Runners who already have a confirmed entry in the race they are eligible to enter the draw for are not eligible to win one of these prizes.
10. Entries won in these prize draws are not eligible for deferral to future editions of the events, except for reasons of pregnancy or postpartum.
11. To receive a deferral for pregnancy or postpartum, a request must be made by sending an email to WMM at [draws@wmmajors.com](mailto:draws@wmmajors.com) prior to the date of the event for which the deferral is being requested.
12. Deferred entries must be used for entry into the following year's event and are not valid beyond this date.
13. A deferred entry applies to the entry only and not to any registration fees paid. Registrants will be required to pay the registration fees when using the deferred entry, and any previously paid fees are not refundable.
14. The total number of entries available for each race are as follows:
  - Sydney 2026: 250
  - Berlin 2026: 250
  - Chicago 2026: 250
  - New York City 2026: 250
  - Tokyo 2027: 300
  - Boston 2027: 150
  - London 2027: 500
15. The prize draw is open to anyone who is 18 years of age or over.
16. Each winner will receive an entry to the marathon they have not yet completed. Winners that are WMM Gold Club members are eligible to receive entry into a marathon they have already completed, if that entry is won through the Gold Club member only draw.
17. The prize draw is not open to employees of WMM, their families, agents or any third party directly associated with administration of the prize draw.
18. The prize draw is free to enter and no purchase is necessary provided that winners of the draw must pay the race entry fee at registration and are responsible for all other event-related expenses.
19. To be eligible to enter, runners must have the required number of stars in their runner portal on [worldmarathonmajors.com](http://worldmarathonmajors.com).
20. All prize draws will open on January 5, 2026. The closing dates and date of each draw for entries are as follows:

21. WMM accepts no responsibility for entries not successfully completed due to a technical fault or malfunction, computer hardware or software failure, satellite, network or server failure of any kind.
22. The winners will be chosen by random draw on the draw dates stated in condition 20.
23. Winners will be drawn randomly by WMM staff. The draw will be witnessed and verified by an independent adjudicator. Subsequently, each winner will be notified by email (using details provided at entry) on or after the day of the draw date.
24. If a winner does not accept the race entry by the date specified by WMM or the applicable event organizer (the “**Organizer**”), then the winner’s prize will be forfeited and WMM will be entitled to select another winner in accordance with the process described above.
25. The entry will be sent to the winner by the Organizer or WMM following confirmation of their acceptance and payment of the applicable event fee.
26. The prize for the winners is non-exchangeable, non-transferable and no cash alternative is offered.
27. The prize is supplied, via WMM, by the applicable Organizer. WMM reserves the right to replace the prize with an alternative prize of equal or higher value if circumstances beyond WMM’s control makes it necessary to do so.
28. The decision of WMM regarding any aspect of the prize draw is final and binding and no correspondence will be entered into about it.
29. Participants are deemed to have accepted and agreed to be bound by these Terms upon entry. WMM reserves the right to refuse entry, or refuse to award the prize to anyone in breach of these Terms.
30. WMM reserves the right to hold, void, cancel, suspend, or amend the prize draw where it becomes necessary to do so.

31. Insofar as is permitted by law, WMM, its agents or distributors will not under any circumstances be responsible or liable to compensate a winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of WMM, its agents or distributors or that of their employees. Your statutory rights are not affected.
32. WMM will make available on request information that indicates that a valid award took place – being the surname and country of the winner. Where applicable, WMM shall provide the information and winning entry to the UK's Advertising Standards Authority on request.

However, please note that the personal data of the winners will be passed to the applicable Organizer to process their entry to the applicable event and the processing of such personal data by the applicable Organizer will be governed by the terms of their privacy policy.

In addition, participation in each event is governed by such event's terms and conditions of entry in force at the relevant time (the "**Entry Terms**"), which each winner will need to accept at the time that they pay the entry fee. Should there be any inconsistencies between a term contained in these Terms and a term contained in the Entry Terms (in particular, without limitation, condition 10 above), the term contained in these Terms shall prevail.
35. Winners may be required to participate in publicity related to the prize draw which may include the publication of their name and photograph in any media. By participating in the prize draw, each winner agrees to all such publicity and use of their name (or any part thereof) by WMM.
36. The prize draw will be governed by English law and entrants to the prize draw submit to the jurisdiction of the English courts.
37. Each eligible runner will be permitted to enter all draws they are eligible for, but are only eligible to win one race entry per race calendar year (i.e. they can only enter one WMM race in any calendar year using entries won via these prize draws, regardless of when the draws are held).
