When asked how one of our team members was able to find success in placing some out most vulnerable clients, she responded with this: "Truthfully, most of the success can be attributed to the hard work of these clients. They pushed through patiently and continued to be persistent." And there you have the magic recipe: slow and steady work and persistence.

After 43 years with BMAC, it's time I leave the slow and steady work in the capable hands of my team. September 1, 2021, marks my retirement, and I'll be off to hit the open road and enjoy life in a new way. I will forever cherish the people and stories that have marked my long tenure with BMAC. The spirit of community action and the knowledge that one person can change a life will forever be with me.
