Re: Dr Aseem Malhotra, GMC number 6029224

This is a further letter deplored the GMC action against Dr Malhotra. We have written to you previously - in October 2023, March 2024, October 2024 and October 2025 - in support of his brave and principled stand in regard to the Covid mRNA products.

Much of the evidence presented against him appears to have been cherry-picked from long interviews. It ignores his detailed review of the published evidence of harms from these genetic products and focuses instead on his opinions as to why so many in the medical profession are still reluctant to face up to the reality of widespread vaccine injuries. Other allegations simply refer to his turn of phrase in social media retweets. Even retweeting a link to a song on YouTube is listed in the allegations. Not one of the allegations reflects any patient complaint nor any actual risk to patient safety.

As you will be aware, he initially recommended Covid vaccines but changed his view after seeing patient harms post-vaccination. Since then, he has followed the GMC's Good Medical Practice guidance to *"Act promptly if you think that patient safety or dignity may be seriously compromised."* The harms he has particularly highlighted have been cardiovascular, including sudden deaths in young adults. More recently he has commented on the documented increase in aggressive cancers, including in younger age groups who would not have been at significant risk from SARS-CoV-2 infection and for whom the risks from the vaccines undoubtedly outweighed any benefits.

As stated in our previous letters, and from everything we have witnessed in our clinical practice or read in the published literature over the last five years, we believe that Dr Malhotra has acted highly responsibly, in line with his ethical duties as a doctor. While his language has sometimes been colourful, this reflects his frustration with the intransigence of the medicines' regulators, who refuse to suspend these products or authorise a full and independent safety analysis.

Censuring Dr Malhotra would have a chilling effect on potential whistleblowers, which would be highly detrimental to patient safety. We would remind you of your statement in previous correspondence, *“It is vital that healthcare has a culture that encourages and supports speaking up about patient safety concerns. This is why we continue to encourage doctors to speak up if they have any concerns, or if they are concerned that they may have experienced a retaliatory or threatening referral.”*

Far from bringing the profession into disrepute, large sections of the public have expressed gratitude to Dr Malhotra and others for having the courage to speak out. This sort of [transparency](#), even around adverse events, is vital for maintaining public trust in medical professionals. Dr Malhotra's views are demonstrably not 'baseless'. He is one of a large number of doctors worldwide alarmed by the failure of the regulators to withdraw these products in the face of clear evidence of serious harm. See for example, the [Hope Accord](#), [The Lighthouse Declaration](#), [MWM-Human Science & Medicine](#) and the [North group](#). Calling his fitness to practice into question will be detrimental to patient safety, by silencing other ethical doctors wishing to report concerns about the Covid vaccines.

Such disproportionate action for social media posting risks bringing the GMC itself into disrepute. The GMC's actions show a total disregard for the large number of UK citizens with disabling vaccine injuries and those bereaved as a result of vaccine harms. Taking someone to a tribunal who has spoken so publicly, in an attempt to protect the public from harm, can only serve to further undermine trust in the profession.

We urge you to recognise these repeated complaints as vexatious, and to immediately drop all action against Dr Malhotra.
