

PROCEEDINGS OF THE MOTT CITY COUNCIL
February 11, 2025

The Council met for their monthly scheduled meeting on Monday, February 10, 2025. Present were Mayor Mosbrucker, Council members Johnson, Steiner, Treichel, K. Messmer, J. Messmer and Wangsvick (via Zoom). Superintendent Brian Steinke, Jerod Klabunde (via phone), Luann Dart and Sheriff Sarah Warner were also present. All motions are carried, unless otherwise stated.

Steiner moved and J. Messmer seconded the approval of the January 2025 meeting minutes.

Jerod Klabunde, from Moore Engineering, joined us via phone to update us on various projects. The small leak on the pump house project has been fixed. The Emergency Water Main Replacement project is ready to go to bid. The big infrastructure project is almost ready to go to bid. We can't bid it until the secondary funding source is secured. A loan with the USDA is in the legal/underwriting departments, so that is in process. A couple of blocks on the East side need some camera work on the plumbing and sewer. Jerod is working to get that set-up with as much lead time as possible for the affected homeowners can be home to let the plumbers in. Lastly Jerod shared with us that HB1577 in the State House could provide a future funding source for sewer infrastructure. It was suggested we contact our local Congressperson to ask them to support it.

J. Messmer moved and Treichel seconded the approval of the police report presented for January. There were 23 calls for service with one 9-1-1 call. Investigations included: suspicious person/vehicle/activity x 2 and exhibition driving. Deputy Parker Kraft has resigned, and a new deputy has been hired, Adam Oldfather. The Deputies have been stopping trucks for Jake braking and giving warnings. The Sheriff asked if we could add a sign south of town. Troy will go to Commissioner's meeting to make sure they don't have a problems with the additional sign. A new deputy was hired, formerly from Adams County, so he has the necessary training, but is still riding along with another Deputy for a bit longer.

Auditor Steinke shared that due to the USDA loan process the City needs an updated water agreement with Southwest Water Authority that is for the length of the loan. SWA is preparing the document and once the City signs SWA will sign at their next meeting on March 3rd.

Superintendent Steinke shared he went to the Landfill class at the end of January to renew his certification. Team Lab wants to know if the City wants them to do lagoon analysis, but City wants the cost first. Still waiting for Dakota pump to fix one of the pump valves in the water tower. Both of the garage heaters at City Hall died, they have been repaired. We have a burn permit for the landfill, just waiting on the best weather conditions to light it. Library toilet needs replacement, the City shop needs plumbing work as well. Just waiting on parts.

J. Messmer moved and Steiner seconded a raffle permit for the Schools Annual Reading Quilts.

Treichel moved and Wangsvick seconded the approval of the bills as presented:
