

## PROCEEDINGS OF THE MOTT CITY COUNCIL

January 13, 2025

The Council met for their monthly scheduled meeting on Monday, January 13, 2025. Present were Mayor Mosbrucker, Council members Johnson, Steiner, Treichel, K. Messmer and Wangsvick (via Zoom). J. Messmer was absent. Superintendent Brian Steinke, Jerod Klabunde, Anthony Setness and Sheriff Sarah Warner were also present. All motions are carried, unless otherwise stated.

Steiner moved and Treichel seconded the approval of the December 2024 meeting minutes.

Johnson moved and Steiner seconded the approval of the police report presented for December. There 27 calls for service with one 9-1-1 call. Investigations included: , suspicious person/vehicle/activity, domestic dispute, terrorizing, burglary/breaking & entering, destruction/damage/vandalism of property/criminal mischief, hit & run, and assist another agency. Deputy Christiansen's last day is January 17<sup>th</sup>. A new deputy was hired, formerly from Adams County, so he has the necessary training, but is still riding along with another Deputy for a bit longer.

Jerod Klabunde was here to review the work on the Pump House and to request that Weisz & Son's be paid for the work. Johnson moved and Treichel seconded. Moore is about a month out from finalizing plans and funding for the next phase of our infrastructure project. Once that is all finalized then the project can go out for bid. Johnson moved and Steiner seconded the approval of Moore's bill payment contingent on funding agency approval. Additional discussion surrounding water meters. Our current water meters are starting to hit the end of their life expectancy. The Council decided to have Moore add it to the current infrastructure project and bid process.

The City was awarded an ergonomic grant through WSI. The City Shop is in need of a hoist to safely maintain the City vehicles. Wangsvick moved and K. Messmer seconded the bid from Benco Equipment for \$12,880.00. The expenses not covered by the grant will be split equally amongst the following funds: Street, Water, Sewer, Garbage, and Curb Stop. Some electrical work will need to be done which the City will bid.

Johnson moved and Steiner seconded designating the Commercial Bank of Mott as the City's depository.

Superintendent Steinke talked about the water break in West Mott. Additionally, per Jerod, he is going to go around town with Kerry to figure out what shut-off valves work and don't work so they can be part of the Infrastructure Project.
