

PROCEEDINGS OF THE MOTT CITY COUNCIL

March 10, 2025

The Council met for their monthly scheduled meeting on Monday, March 10, 2025. Present were Mayor Mosbrucker, Council members Steiner, Treichel, K. Messmer, J. Messmer and Wangsvick (via Zoom). Councilman Johnson was absent. Superintendent Brian Steinke, Luann Dart Tom Irwin, Rick Poehls, Helen Schaible, Deputy Kenney Pippenger and Deputy Jordan Malchose were also present. All motions are carried, unless otherwise stated.

Steiner moved and K. Messmer seconded the approval of the February 2025 meeting minutes.

J. Messmer moved and Steiner seconded the approval of the police report presented for February. There were 7 calls for service with one 9-1-1 call. There were no investigations in February. Deputy Jordan Malchose, a newer hire, was introduced to the Council.

Auditor Steinke shared that Jerod from Moore Engineering is on vacation but did send an update. All the plans and specs for the next phase of work have been completed and sent to the USDA. The Millionaire/Montana/Wyoming blocks were scoped out the previous week by HA Thompson. Most sewers were clear though a couple did show clay pipes. All the curb stops were marked out for the home owners and they were told to expect work to be in a 5' radius of the curb stops. Some were in bad spots that will likely be change. The contractor will work with the City and Moore on those locations.

The Landfill will open the weekend of April 12th. Spring Clean-up Week will be the April 26 – May 4th with the City Council doing their Annual Tour of the City prior to the May 12th meeting.

Superintendent reported that the Mott Motel's Curb Stop and plumbing issues have been resolved. The guys started getting ready to work on the streets and discovered the big air compressor was leaking so they are working on that. One lift station swing arm valve is down. Both the lifts went in at the same time so the Superintendent is gathering quotes to replace both valves.
