

# Riparian Plant Propagation Program Conservation District Projects

Fiscal Year 2026

The Riparian Plant Propagation Program (RPPP) provides annual funding to conservation districts to support the cultivation of native trees and shrubs for riparian restoration.

#### Funding in 2026 supports:

- Procuring native trees and shrubs for propagation
- Maintaining plants at existing holding sites
- Improving, expanding, or establishing holding sites



# **Clark Conservation District** \$237,156

Clark Conservation District is purchasing 7,366 native trees and shrubs, and while maintaining 40,000+ existing plants at its holding site, supported through a partnership with the Lower Columbia Fish Enhancement Group.



## **Columbia Conservation District** \$45.000

Columbia Conservation District is maintaining 750 native trees and shrubs at its holding site in partnership with the Dayton School District.



#### **Ferry Conservation District** \$4 533

Ferry Conservation District is maintaining native trees and shrubs at its holding site while completing minor site repairs to improve long-term nursery function.



### **Grays Harbor Conservation District** \$14.950

Grays Harbor Conservation District is maintaining 14,950 native plants at its holding site, operated in partnership with the Port of Grays Harbor.



#### **Jefferson County Conservation District** \$45.822

Jefferson County Conservation District is maintaining 3,500 native plants and purchasing an additional 1,800 trees and shrubs through a partnership with the North Olympic Salmon Coalition.



#### King Conservation District

\$100,904

King Conservation District is maintaining 12,000 native trees at the Wetland Plant Cooperative and Native Plant Holding Facility, supporting regional restoration work.



#### **Kitsap Conservation District** \$21.876

Kitsap Conservation District is purchasing 7,200 new plants and maintaining 10,587 trees and shrubs in gravel beds at its holding site to strengthen local restoration capacity.



### North Yakima Conservation District \$50.829

North Yakima Conservation District is purchasing 1,100 native trees and shrubs and maintaining 9,385 existing plants for upcoming riparian restoration projects.



#### **Palouse Conservation District** \$44.703

Palouse Conservation District is purchasing 6,800 native trees and shrubs, while maintaining 5,000 existing plants at its holding site in partnership with Washington State University.

#### Pend Oreille Conservation District

Pend Oreille Conservation District is purchasing 1,000 native trees and shrubs, while maintaining 3,500 existing plants in partnership with the Kalispel Tribe of Indians.



# **Spokane Conservation District** \$272,782

Spokane Conservation District is purchasing 4,000 new plants, maintaining 45,000 existing plants, and repairing its holding site cooler to support ongoing propagation work.



#### **Snohomish Conservation District** \$251.684

Snohomish Conservation District is maintaining 4,160 container plants at its holding site, operated in partnership with Snohomish County.



#### Underwood Conservation District

Underwood Conservation District is maintaining 500 native plants and purchasing 8,621 additional plants for its holding site in partnership with the historic Wind River Nursery.



#### **Whatcom Conservation District** \$92.971

Whatcom Conservation District is purchasing 18,050 native plants, while maintaining 17,775 existing trees at its holding site, supported through a partnership with the Nooksack Salmon Enhancement Group.



#### **Whitman Conservation District** \$11.200

Whitman Conservation District is maintaining 2,000 native trees and shrubs at its holding site to support ongoing riparian restoration efforts.
