Payment/Removal of Property - Payment terms are instructed on the 2025 Surplus Sale — Bid Submittal Form. Payment will be coordinated by MEA's Procurement department and a completed Bill of Sale provided upon payment in full prior to removal of purchased items. MEA will <u>not</u> assist in the removal of items so please plan accordingly. Defects may exist and repairs may be needed. Buyer must pack, load, and remove. Removal by appointment only.
