INSTRUCTIONS TO VOTERS: To vote on the following question, place an "X" in the square to the right of the words "IN FAVOR OF ISSUING BONDS TO THE AMOUNT OF \$8,700,000 FOR THE PURPOSE STATED IN ORDINANCE No. 2485," OR "AGAINST ISSUING BONDS TO THE AMOUNT OF \$8,700,000 FOR THE PURPOSE STATED IN ORDINANCE No. 2485" according to the way you desire to vote on the question. If you, by mistake or accident, mark, tear, deface, or otherwise mutilate this ballot, return it to the Election Judges and obtain another ballot.

QUESTION: Shall the City of Idaho Falls, Idaho (the "City") issue and sell its negotiable general obligation bonds in the amount of \$8,700,000 for the purpose of financing the design, acquisition and construction of a new community recreation center, and to pay costs of issuance of such bonds, said bonds due in such installments as fixed by the City Council of the City, the last installment due and payable not more than twenty (20) years from the date of the bonds, as more fully provided in Ordinance No. 2485 adopted by the City Council of the City on March 27, 2003?

The following information is required by § 34-440, Idaho Code: The total existing bonded indebtedness, including interest accrued, as of May 27, 2003, of the City, is \$58,815,330.37. The interest rate anticipated on the proposed negotiable bonds is four and one-half percent (4.5%). The range of anticipated rates is from one percent (1%) to five percent (5%). The total amount to be repaid over the life of the proposed negotiable bonds, based on the anticipated interest rate, is \$13,233,075.
