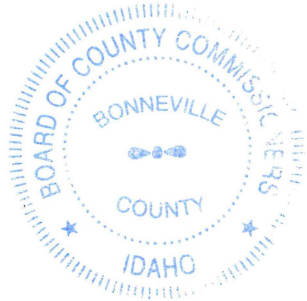
BALLOT QUESTION SHELLEY JOINT SCHOOL DISTRICT NO. 60 SPECIAL GENERAL OBLIGATION BOND		
PRECINCT	Shall the Board of Trustees of Joint School District No. 60, Bonneville and Bingham Counties, State of Idaho (the "District"), be authorized to issue general obligation school bonds of said District in the principal amount of up to \$7,500,000 for the purpose of financing the costs of (i) renovating and improving Goodsell Elementary for future kindergarten and Special Services Center; (ii) renovating and improving HVAC systems at Hobbs Middle School; (iii) updating technology throughout District, including new camera systems and electronic doors; and (iv) constructing, furnishing and equipping school facilities, and making improvements to existing schools and school facilities, including all lighting, heating, ventilation and sanitation facilities and appliances necessary to maintain and operate said buildings and facilities (collectively, the "Project"), together with costs and expenses related thereto, such bonds to become due in such installments as may be fixed by the Board, the final installment of such bonds to fall due not later than September 15, 2028, all as provided in the Resolution adopted by the Board on December 17, 2020?
