<b>PRECINCT</b>	Shall the Board of Trustees of Joint School District No. 60, Bingham and Bonneville Counties, State of Idaho (the "District"), be authorized to issue general obligation school bonds of said District in the principal amount of up to \$67,800,000 for the purpose of financing the costs of (i) acquiring and constructing a new high school and (ii) renovating and improving other existing school facilities, together with all equipment and facilities necessary to operate said building, facilities and improvements and costs and expenses related thereto, such bonds to become due in such installments as may be fixed by the Board, the final installment of such bonds to come due not later than twenty (20) years from the date of issuance, all as provided in the Resolution adopted by the Board on August 17, 2023?

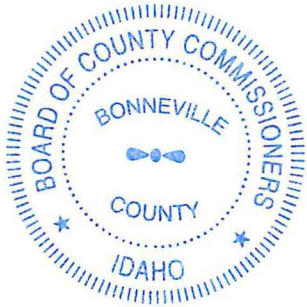
