	<p>Shall the Board of Trustees of School District No. 91, Bonneville County, State of Idaho (the "Board"), be authorized to issue general obligation school bonds of said District in the principal amount not to exceed \$110,000,000 for the purpose of financing the costs of (i) renovating, repairing, equipping and furnishing Skyline High School; and (ii) constructing, furnishing and equipping a new Idaho Falls High School, together with all related furnishings and equipment necessary to operate said facilities (collectively, the "Project"), such bonds to become due in such installments as may be fixed by the Board, the final installment of which to fall due not later than twenty years (20) years from the date of issuance of such bonds, all as provided in the Bond Election Resolution adopted by the Board on July 25, 2017?</p>

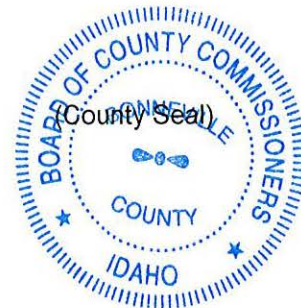
