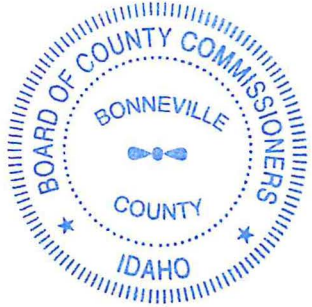
BALLOT QUESTION IDAHO FALLS SCHOOL DISTRICT NO. 91 PLANT FACILITIES LEVY		
PRECINCT	Shall the Board of Trustees of School District No. 91, Bonneville County, State of Idaho (the "District") be authorized and empowered, upon the affirmative vote of fifty-five percent (55%) of the electors of the District voting in the election, to levy a School Plant Facilities Reserve Fund Levy in the amount of up to Two Million Four Hundred Forty Thousand Dollars (\$2,440,000) for Fiscal Year beginning July 1, 2022, and continuing each year in the amount of up to Two Million Four Hundred Forty Thousand Dollars (\$2,440,000) for ten (10) years through fiscal year ending June 30, 2032, for the purposes permitted by law for school plant facilities levies?
