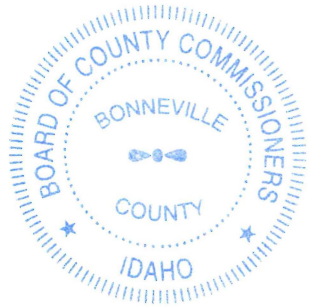
BALLOT QUESTION SWAN VALLEY SCHOOL DISTRICT NO. 92 PLANT FACILITIES LEVY		
PRECINCT	Shall the Board of Trustees of School District No. 92, Bonneville County, Idaho be authorized and empowered to levy a School Plant Facilities Reserve Fund Levy in the amount of \$60,000, sixty thousand dollars, for the first (1st) fiscal year beginning July 1, 2021 and continuing each year in the amount of \$60,000, sixty thousand dollars for 2 (TWO) years for the purpose of allowing the District to acquire, purchase or improve school site or sites; to accumulate funds for and to build a school house or school houses or other building or buildings; to demolish or remove school buildings; to add to, remodel or repair any existing building; to furnish and equip any building or buildings, including all lighting, heating, ventilation and sanitation facilities and appliances necessary to maintain and operate buildings of the District; to purchase school buses; for lease and lease purchase agreements for any of the above purposes and to repay loans from commercial lending institutions extended to pay for the construction of school plant facilities?
