**BALLOT QUESTION
BONNEVILLE JOINT SCHOOL DISTRICT NO. 93**

QUESTION: Shall the Board of Trustees of Joint School District No. 93, Bonneville and Bingham Counties, State of Idaho (the "Board"), be authorized to issue general obligation school bonds of said District, in one or more series, in the total principal amount not exceeding \$92,000,000 for the purpose of financing costs of (i) acquiring, constructing, equipping and furnishing a new high school and a new middle school; (ii) acquiring, constructing, equipping and furnishing facilities for providing professional technical education; (iii) repairing, renovating, equipping and furnishing existing schools and facilities in the District; (iv) purchasing media center and curriculum resources; (v) making safety, security and technology upgrades throughout the District; (vi) purchasing improved and unimproved land for future school sites and school facilities; (vii) acquiring, constructing, equipping and furnishing transportation facilities; and (viii) purchasing buses (collectively, the "Project"), such series of bonds to become due in such installments as may be fixed by the Board, the final installment of each series to fall due not later than thirty (30) years from the date of issuance of the series of bonds, all as provided in the Bond Election Resolution adopted by the Board on January 15, 2014?



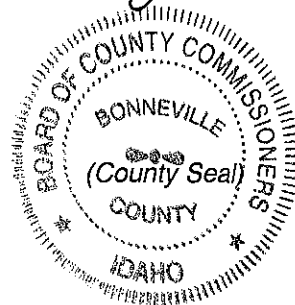
