PRECINCT	Question No. 1: High School Shall the Board of Trustees of Joint School District No. 93, Bonneville and Bingham Counties, State of Idaho (the "Board"), be authorized to issue general obligation school bonds of said District, in one or more series, in the principal amount not to exceed \$55,300,000 for the purpose of financing the costs of acquisition, construction, furnishing and equipping of a new high school, including all relevant lighting, heating, ventilation and sanitation facilities and appliances necessary to maintain and operate the foregoing building and facilities, such series of bonds to become due in such installments as may be fixed by the Board, the final installment of each series to fall due not later than seventeen and one-half (17.5) years from the date of issuance of the series of bonds, all as provided in the Bond Election Resolution adopted by the Board on September 9, 2015?		Question No. 2: Auditorium and Athletic Stadium Shall the Board of Trustees of Joint School District No. 93, Bonneville and Bingham Counties, State of Idaho (the "Board"), be authorized to issue general obligation school bonds of said District, in one or more series, in the principal amount not to exceed \$8,200,000 for the purpose of financing the costs of acquisition, construction, furnishing and equipping, in conjunction with a new high school if approved by the electors of the District under Question No. 1 above, of an auditorium and an athletic stadium, including all relevant lighting, heating, ventilation and sanitation facilities and appliances necessary to maintain and operate the foregoing building and facilities, such series of bonds to become due in such installments as may be fixed by the Board, the final installment of each series to fall due not later than seventeen and one-half (17.5) years from the date of issuance of the series of bonds, all as provided in the Bond Election Resolution adopted by the Board on September 9, 2015?



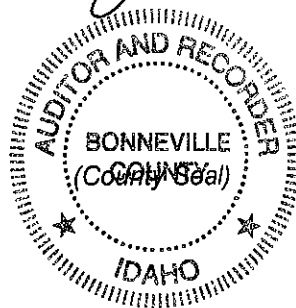
