### JOINT SCHOOL DISTRICT NO. 93, BONNEVILLE AND BINGHAM COUNTIES, STATE OF IDAHO SUPPLEMENTAL MAINTENANCE AND OPERATIONS LEVY ELECTION

Shall the Board of Trustees of Joint School District No. 93, Bonneville and Bingham Counties, State of Idaho (the "District"), be authorized and empowered to levy a supplemental levy, as provided in Section 33-802(3), Idaho Code, in the amount of up to five million eight hundred thousand dollars (\$5,800,000.00) each year for two years, for the purpose of paying all lawful expenses of maintaining and operating the schools of the District for the fiscal years beginning July 1, 2017, and ending June 30, 2019, all as provided in the Resolution of the District's Board of Trustees adopted December 14, 2016?

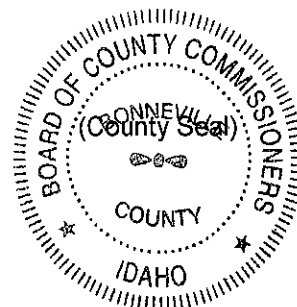
