	IN FAVOR OF	AGAINST
	Shall the Board of Trustees of Joint School District No. 93, Bonneville and Bingham Counties, State of Idaho (the "Board"), be authorized to issue general obligation school bonds of said District in the principal amount not to exceed \$35,319,840 for the purpose of financing the costs of acquisition, construction, furnishing and equipping of (i) a new middle school, including all relevant lighting, heating, ventilation and sanitation facilities and appliances necessary to maintain and operate the foregoing building and facilities; (ii) replacing the roof at Iona Elementary School; (iii) constructing safety improvements at Falls Valley Elementary School including improved student drop-off area; and (iv) land acquisition for future school sites and design work for upgrades to Bonneville and Hillcrest High Schools, such bonds to become due in such installments as may be fixed by the Board, the final installment of such bonds to fall due not later than seventeen and one-half (17.5) years from the date of issuance of such bonds, all as provided in the Bond Election Resolution adopted by the Board on January 17, 2018?

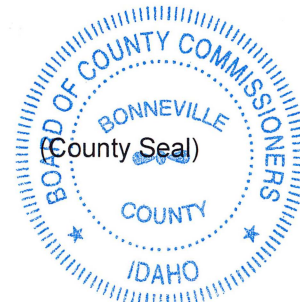

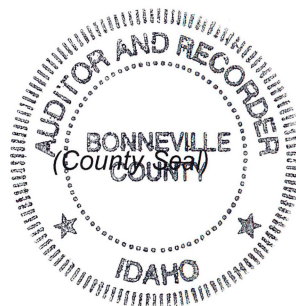
