BONNEVILLE JOINT SCHOOL DISTRICT NO. 93 BOND ELECTION		
PRECINCT	Shall the Board of Trustees of Joint School District No. 93, Bonneville and Bingham Counties, State of Idaho (the "Board"), be authorized to issue general obligation school bonds of said District in the principal amount not to exceed \$42,700,000 for the purpose of financing the costs of (i) acquisition, construction, furnishing and equipping of a new elementary school, including all relevant lighting, heating, ventilation and sanitation facilities and appliances necessary to maintain and operate the foregoing building and facilities; (ii) acquisition, construction, furnishing and equipping additions to Bonneville High School and Hillcrest High School; and (iii) making improvements to existing schools and facilities throughout the District; such bonds to become due in such installments as may be fixed by the Board, the final installment of such bonds to fall due not later than seventeen (17) years from the date of issuance of such bonds, all as provided in the Bond Election Resolution adopted by the Board on July 8, 2019?

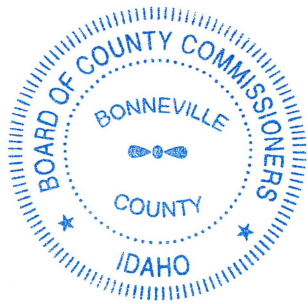

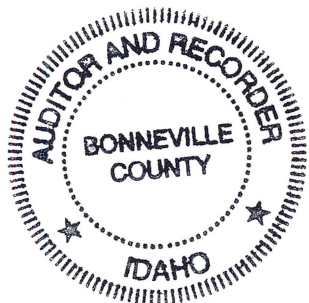
