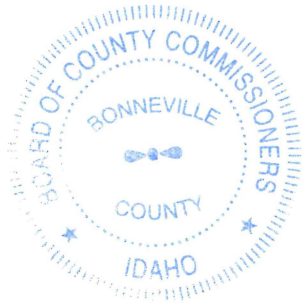

PRECINCT	Shall the Board of Trustees of Joint School District No. 93, Bonneville and Bingham Counties, State of Idaho (the "District") be authorized and empowered, upon the affirmative vote of sixty percent (60%) of the electors of the District voting in the election, to levy a School Plant Facilities Reserve Fund Levy in the amount of up to Three Million Eight Hundred Thousand Dollars (\$3,800,000), for fiscal year beginning July 1, 2021, and continuing each year in the amount of up to Three Million Eight Hundred Thousand Dollars (\$3,800,000) for ten (10) years through fiscal year ending June 30, 2031, for the purposes permitted by law for school plant facilities

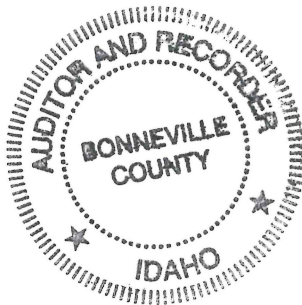
