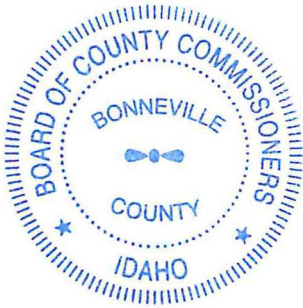

BALLOT QUESTION BONNEVILLE JT. SCHOOL DISTRICT NO. 93 BOND		
PRECINCT	Shall the Board of Trustees of Joint School District No. 93, Bonneville and Bingham Counties, State of Idaho (the "District"), be authorized to issue general obligation school bonds of said District in the principal amount of up to \$34,500,000 for the purpose of financing the costs of (i) constructing a new elementary school, together with all equipment and facilities necessary to operate the new elementary school, at an estimated cost of \$32,000,000 and (ii) repairing and replacing roofs on school buildings throughout the District at an estimated cost of \$2,500,000, including costs and expenses related thereto, such bonds to become due in such installments as may be fixed by the Board, the final installment of such bonds to come due not later than seventeen (17) years from the date of issuance, all as provided in the Resolution adopted by the Board on March 8, 2023?
