## Registration Policies & Procedures – Summer 2026

### A. ELIGIBILITY REQUIREMENTS

- Must be able to be supported in a 1:5 ratio, we have very limited capacity for more individualized supports
- Ambulatory and physically able to participate in an active camping program (our facility is not fully wheelchair accessible)
- Must be reasonably proficient in activities of daily living such as eating, toileting, bathing and shaving and must sleep through the night- no awake 3<sup>rd</sup> shift is provided
- Does not require physical intervention for behavioral concerns

### B. DEPOSIT AND EXTRA FEES

- ♦ A non-refundable deposit of \$400 is required for registration unless being paid by a third party-authorization is required-it is your responsibility to insure funding is in place.
- ♦ Other fees may be incurred i.e. prescription refills due to insufficient supply provided, returned check fee, and **late pickup fee**. Late pickup is not offered as an option. A fee will be imposed. Late pickup may jeopardize camper's future attendance.

### C. REFUND POLICY

- ♦ No full refunds are given after June 1st.
- ♦ Partial refunds on fees after June 1st, are given for the following circumstances:
  - The camper cannot attend camp due to illness or injury occurring before camp and the condition is confirmed in writing by physician. We will refund all tuition paid less \$100 administrative fee.
  - If the camper becomes ill while at camp, fees for weeks (part or whole) already attended are charged, then the remaining balance is refunded less \$100 administrative fee.
  - If camper leaves camp for any reason other than medical, fees for weeks (part or whole) already attended are charged, then the remaining balance is refunded less \$400 deposit.

### Register your camper :

1. Register online at [www.horizonsct.org](http://www.horizonsct.org) –if you have not yet used the online registration portal or have forgotten your password -use the “password reset” option to access your account after clicking “Register Online”.
2. Submit your deposit online via credit card OR via mail to Horizons, Inc. PO Box 323 South Windham, CT 06266-please note that we do not accept credit card payments for the balance due.
3. Complete waivers and any needed Medical Forms by June 1st. Please refer to your confirmation which will be sent after registration for any outstanding forms needed.
4. You may access your camper's medical forms and current information on file as needed by utilizing the online registration portal. Choose “Camper Records” and “Forms on File” to view.
5. Check the FAQs at [www.horizonsct.org](http://www.horizonsct.org) as needed for updates.

### CAMP FEES & REGISTRATION DATES

**Fees include:** daily program activities, meals, supervision in a 1:5 ratio, administration of medications, evening activities, accident insurance coverage, camp t-shirt, group photo & more!

If you feel your camper would benefit from a **one week session**, or we have suggested this for your camper please reach out to secure a spot. A small number of one week spots are set aside-cost is \$2479.

Day camp options are also available on a very limited basis.

Also available upon request - a special one week session July 19-24<sup>th</sup> -for campers under the age of 26 in conjunction with our partnership with the Epilepsy Foundation's Camp Courage. Pricing for Camp Courage is \$2211.

Fees are to be paid in full by June 1, 2026 or authorization received from third party-please insure you have followed up with your payor to determine your funding is in place.
