

2026 Eligibility Requirements for MDRT Annual Meeting, MDRT Global Conference and MDRT EDGE

For Academy members and mentees

As a current MDRT Academy member or enrolled mentee in the MDRT Mentoring Program, you are eligible to qualify to attend the MDRT Annual Meeting, MDRT Global Conference or MDRT EDGE. The following criteria must be met in order to attend.

MDRT Annual Meeting

- Advisors may attend a maximum of two MDRT Annual Meetings while they are MDRT Academy members or while they are enrolled in the MDRT Mentoring Program.
- Advisors interested in participating in the MDRT Mentoring Program and/or attending an MDRT meeting must join the MDRT Academy. However, the MDRT Academy is not available in Japan, Korea, Bahrain and Mainland China, so advisors in these countries may join the MDRT Mentoring Program in order to qualify for meeting attendance.
- Advisors must join the MDRT Academy or the MDRT Mentoring Program, with the above stipulations, by March 31 of the meeting year to be eligible to attend the MDRT Annual Meeting.
- To attend the first MDRT Annual Meeting, advisors must meet a production requirement threshold of 50% of eligible commissions paid, 50% of eligible premiums paid or 50% of eligible income earned for the meeting year (based on the member's previous year's production).

Total commissions: USD 43,500

Total premiums: USD 87,000

Total income: USD 75,500



MDRT MEETING QUALIFICATIONS

For Academy members and mentees

- To attend the second MDRT Annual Meeting, advisors must meet a production requirement threshold of 75% of eligible commissions paid, 75% of eligible premiums paid or 75% of eligible income earned for that meeting year (based on the member's previous year's production).
 - Total commissions: USD 65,250
 - Total premiums: USD 130,500
 - Total income: USD 113,250
- If qualifying as a mentee from Japan, Korea, Bahrain or Mainland China, the advisor's mentor must also be registered to attend the MDRT Annual Meeting. The mentor must be registered before the mentee can register.
- Once they have qualified, Academy members will receive an email from MDRT that provides additional registration information. This email will be sent after March 31. Mentees will receive an email after general registration has opened to allow time for mentors to register.
- If advisors have previously attended an MDRT Annual Meeting as an MDRT member, they are permitted to attend one MDRT Annual Meeting as an MDRT Academy member or mentee after reaching an MDRT production requirement threshold of 75% of eligible commissions paid, 75% of eligible premiums paid or 75% of income earned for the meeting year (based on the member's previous year's production).
- If production is submitted on a data file sent by the company, then no certifying letter is required for validation. If the MDRT Academy member is submitting production individually, a commission and premium certifying letter or income form signed by an official of the company is required. Completed files can be submitted to info@mdrtacademy.org.
- All MDRT Academy members and mentees will pay the same registration fee as MDRT members. Payment is due at the time of registration.

MDRT Global Conference and/or MDRT EDGE

- All MDRT Academy members and mentees are eligible to attend the MDRT Global Conference or MDRT EDGE. There is no minimum production requirement to attend. The MDRT EDGE meeting is only available to advisors in the U.S. and Canada.
- MDRT Academy members will pay the MDRT member registration fee (less than the non-member meeting registration fee) to attend the MDRT Global Conference and/or MDRT EDGE.
