Position Summary:

Responsibilities:

Primary duties include, but are not limited to, the following:

- Be able to independently test, troubleshoot, diagnose, and repair electronics product.
- Skilled to troubleshoot down to PC-Board and component level.
- Independently repair customer returned equipment on time and with high quality.
- Work well in a team environment, with other technicians, customer service reps, and quality.
- Support required company performance metrics such as On Time Delivery (OTD) and Turn Around Time (TAT).
- Completion of Training is targeted to be 3 months. Rectification (if applicable) is required every two years unless otherwise specified in the course itself

Qualifications:

- Associate degree or 2+ years of related work experience as technician in electronics field.
- Able to read schematic and bill of materials, understand electrical circuits
- Able to trouble shoot failed electronics down to component level
- Know how to use test equipment such as oscilloscope, power analyzer, multiple-meter,
- Able to perform re-work tasks to remove and re-install SMT and through-hole components with solder iron
